The closest underground stations are Knightsbridge and Sloane Square.

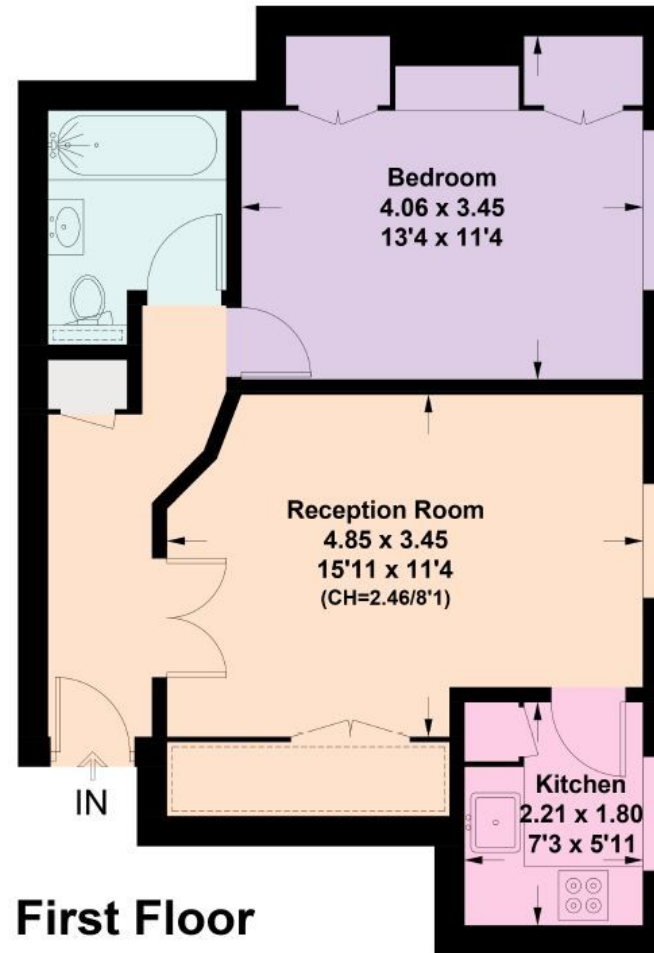
