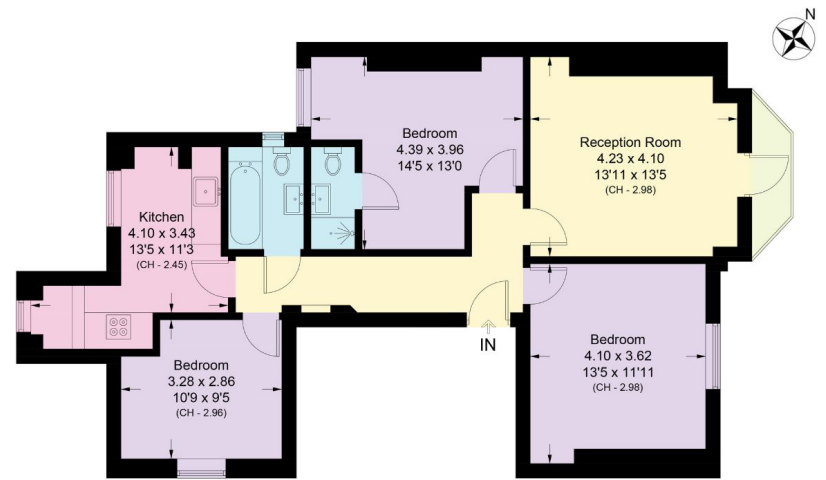


The flat is set on the fourth floor (no lift) in the popular Wymering Mansions and requires a full refurbishment.
