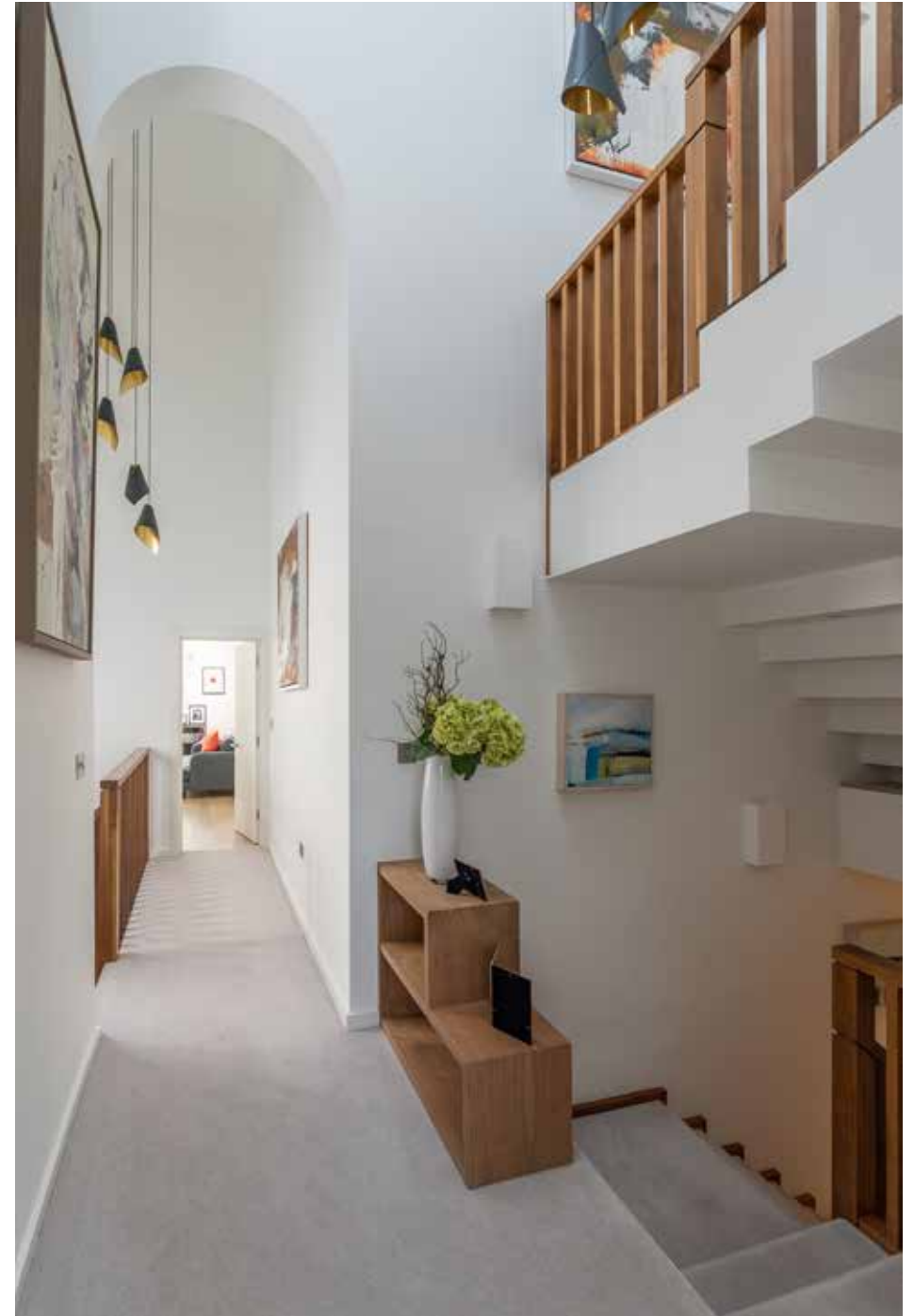

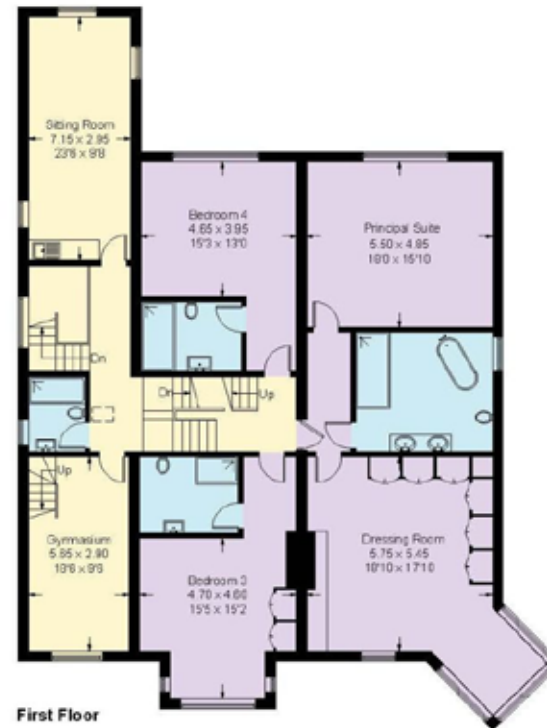
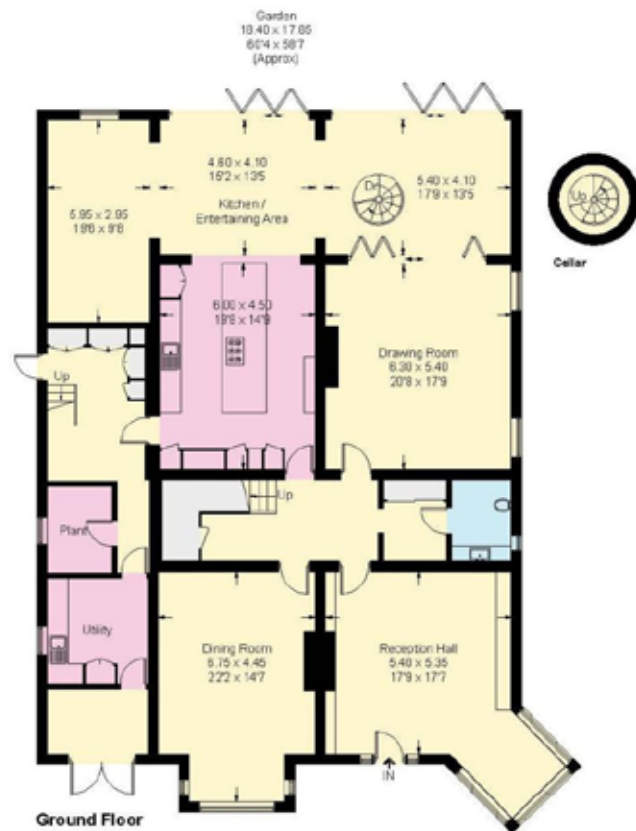
ABOUT THE PROPERTY
