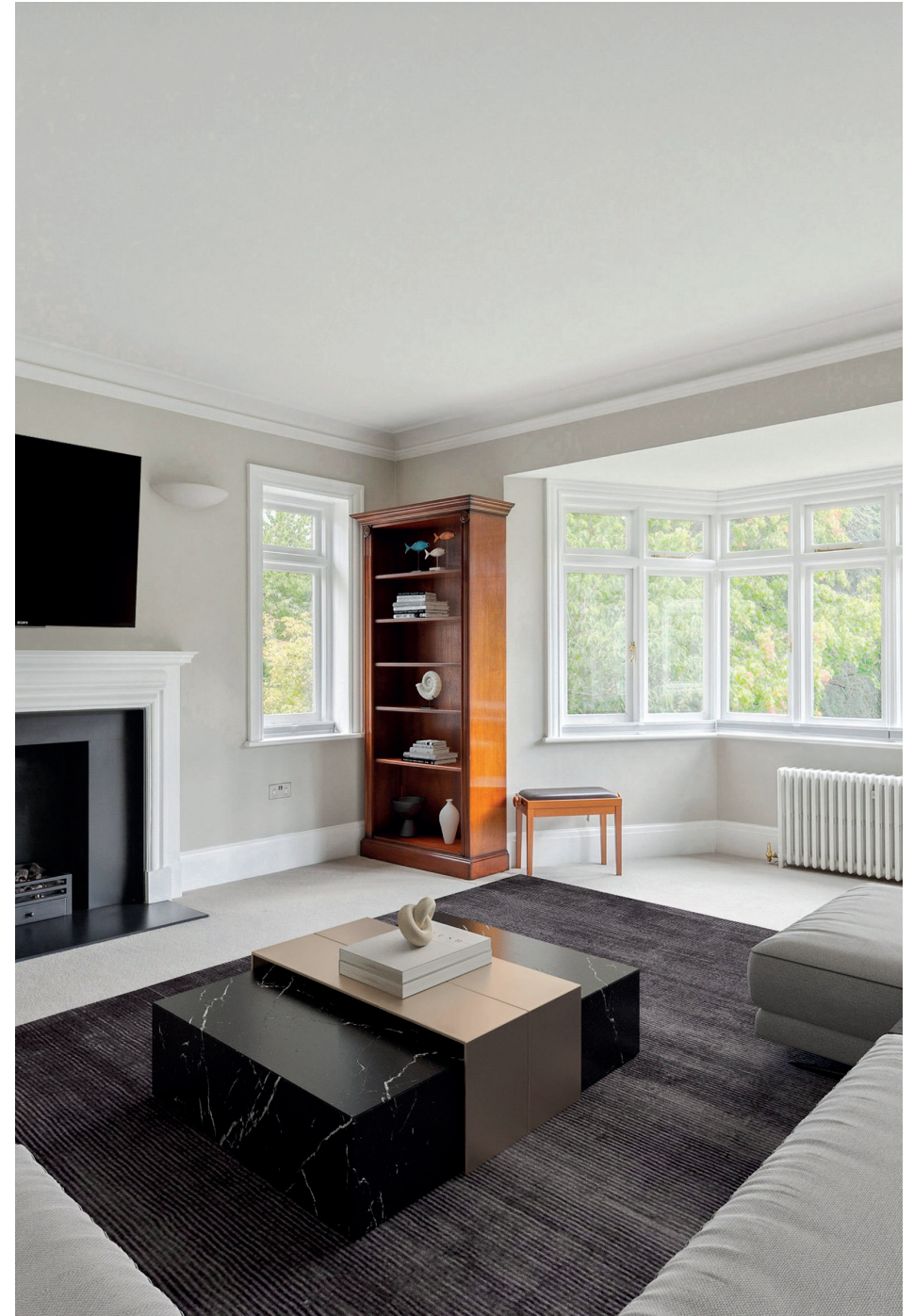




## A PERFECT BALANCE BETWEEN STYLE AND COMFORT

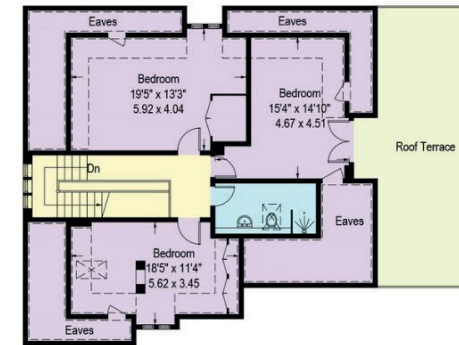
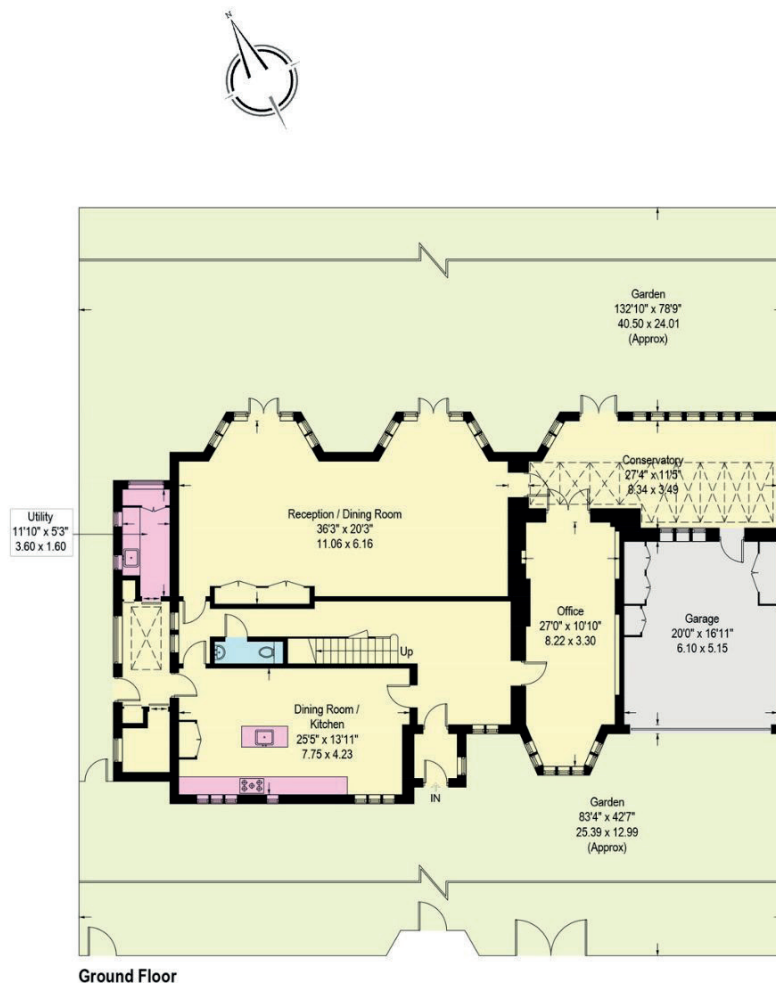




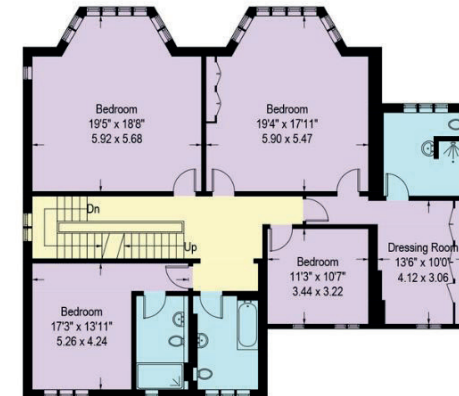








Second Floor
