ABOUT THE PROPERTY

Located at the top of Wimbledon Hill near Wimbledon Village, this five-bedroom, three-bathroom home sits within a gated development offering privacy and security. Set over four spacious levels, the modern brick house features a covered portico entrance, leading into a bright entrance hall, separate kitchen/breakfast room, and a large open-plan living space with access to a south-facing deck framed by tropical planting. Three bedrooms are on the first floor, including one with a Juliet balcony. The top floor is dedicated to a private principal suite with a walk-in wardrobe, full en suite, fitted storage, and a secluded roof terrace. The lower ground level includes a fifth bedroom or study with garden access—ideal for a potential annexe—plus a utility room, cloakroom, and internal access to a double garage. Secure gates open to a private driveway with off-street parking, all just near to the shops, cafes, and green spaces of Wimbledon Village.







