The property is ready to move into, presented to a show home standard, neutral colour pallet, high-quality window shutters, fitted front and rear (except the conservatory).

The accommodation arranged over two floor, comprises an entrance hallway, spacious front lounge with dual aspect windows, modern ground floor shower room, modern grey fully fitted kitchen, under stairs storage and opening into a full width brick based conservatory, providing a lovely open plan kitchen / diner, ample natural light and access into the the private enclosed rear garden.

The first floor comprises two generous sized double bedrooms, the master to the front of the property with dual aspect windows and fitted shutters. The rear with one double glazed window, fitted shutters and built in storage.

The rear garden is fence enclosed, private, low maintenance, comprising a paved patio, slate chippings and gated side access to a large tarmac parking area with rear vehicular access. There is also a small low maintenance front garden with slate clippings and steps with rail to the front door.

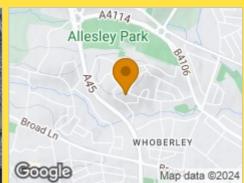




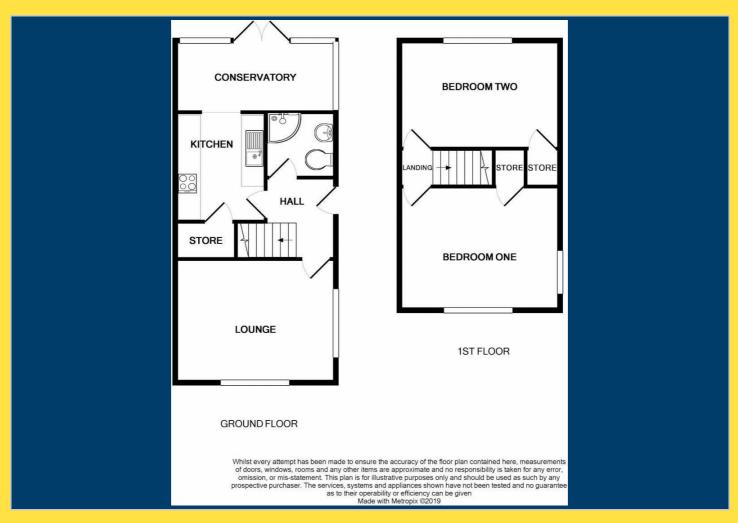
Road Map Hybrid Map Terrain Map







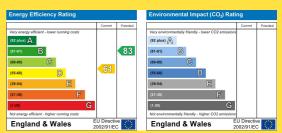
Floor Plan
