GROUND FLOOR

Living Room

13'0" x 14'8" (3.97 x 4.49)

A spacious living area located to the front of the property. It has carpeted flooring, a large double glazed window, radiator and uPVC door leading out to the front of the property. It also boasts a beautiful fireplace and provides access to the Kitchen Diner.

Kitchen Diner

10'9" x 26'8" (3.29 x 8.14)

The Kitchen Diner is located to the rear of the property. It has Wooden flooring, large double radiator, uPVC stable door leading to the Rear Garden and two double glazed windows. Access is provided to the Living Room, First Floor via stairs, Bedroom Four/Office and Conservatory. There are ample wall and base units with incorporated worktop and Belfast sink with mixer tap. Integrated appliances include a dishwasher, Fridge Freezer and space for a large cooker.

Bedroom Four

9'10" x 10'6" (3.02 x 3.21)

A good sized double bedroom located to the front of the property which is currently being used as an Office. It has carpeted flooring and a large double glazed window with radiator below.

Conservatory

11'2" x 9'3" (3.42 x 2.82)

A great addition to the property which is located to the rear of the property. It has double glazed windows and double glazed French Doors leading out to the Rear Garden. The flooring is tiled and also boasts underfloor heating.

Landing

The Landing is carpeted and provides access to Bedrooms One, Two and Three, the Bathroom and the Shower Room as well as the second floor via stairs.

Bedroom One

13'1" x 14'8" (4.00 x 4.49)

An extremely spacious double bedroom located to the front of the property. It has carpeted flooring and a large double glazed window with radiator below. It also has the added advantage of floor to ceiling, fully integrated wardrobes.

Bathroom

10'7" x 8'0" (3.25 x 2.46)

A large bathroom located to the rear of the property. It has tiled flooring and part tiled walls. There is a large chrome heated towel rail, double glazed window with obscured glass and storage cupboard. There is a three piece bathroom suite which includes a low flush WC, pedestal wash basin and large bath tub.

Bedroom Two

8'3" x 11'10" (2.52 x 3.63)

Double bedroom located to the rear of the property which has wood effect laminate flooring and a double glazed window with radiator below.

Shower Room

7'6" x 4'9" (2.30 x 1.45)

A new addition to the property is the shower room. It is located to the rear and has tiled flooring, Chrome heated towel rail and extractor fan. There is a low flush WC, pedestal wash basin and large shower cubicle.

Bedroom Three

9'10" x 11'7" (3.00 x 3.55)

A spacious bedroom located to the front of the property with wood effect laminate flooring and double glazed window with radiator below.

SECOND FLOOR

Office/Occasional Room

11'1" x 26'4" (3.38 x 8.05)

A spacious room which has carpeted flooring and two double glazed windows with radiator below. There is also ample storage space within the eaves.

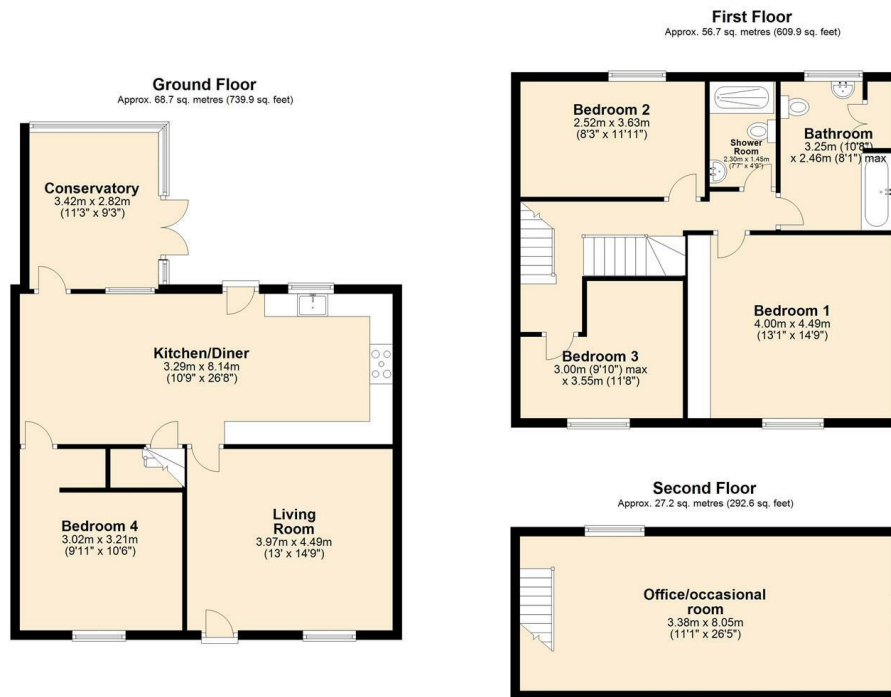
EXTERNAL
