Description

Bay Tree Cottage is a beautifully presented period cottage, situated in the popular village of West Charleton. This bright and spacious property is full of character features including exposed stone work, beams, tiled flooring and a spiral staircase.

You enter at the side of the property into the hall, there is a cloakroom on the left and door straight ahead of you in to the spacious 'L' shaped sitting room. To the rear are glazed doors opening to the garden flanked either side by full height windows allowing natural light to flood in. There's a bespoke spiral staircase and an attractive stone wall dividing the sitting room from the kitchen which has built-in storage and 'window' style openings either side of the open walkway between both rooms. The kitchen is dual aspect and has a view out to the front, it's well-equipped with plenty of fitted floor and wall units, Rayburn, Rangecooker, Belfast sink and has ample room for a dining table and chairs.

Upstairs there's a family bathroom and 3 double bedrooms. The principal bedroom enjoys en-suite facilities, built-in storage and has a Juliette balcony allowing you to take-in the lovely views over the garden to countryside beyond.

There is a loft which has been boarded and has a fold down ladder for access.

The private, south facing rear garden is bound on all sides by stone walling, topped with timber fencing with borders of established plants, shrubs and trees. There's a large patio seating area, ideal for entertaining/al fresco dining, a summerhouse with plumbing and electric connected, currently used as a utility, a hot tub and at the far end is a large timber framed home office/play room/store which also has power connected.

Situation

The popular village of West Charleton benefits from a pub, church, and primary school. The market town of Kingsbridge is close by and offers a wide range of commercial, leisure and shopping facilities, including a Primary School and Community College. There are walks across fields to the shores of the Kingsbridge/Salcombe Estuary, and the famous sailing centres of Salcombe and Dartmouth are also within easy reach as well as an abundance of sandy beaches and coves with miles of coastal footpaths.






