Having the benefit of gas central heating and uPVC double glazing, the accommodation comprises in brief, living/dining room, modern fitted kitchen with integrated appliances, two bedrooms and a shower room with a white three-piece suite. Accessed via steps up to a double glazed door to the side aspect into the light and airy living/dining room with three windows to the side and one to the front aspect, radiator and fireplace with wooden surround and hearth, fitted kitchen having a range of wall and base units, sink and drainer, integrated oven and gas hob with an extractor above, space and plumbing for a washing machine and fridge freezer and door out to the gravelled area. Inner hallway with a storage cupboard and doors off to two bedrooms and a shower room with a three-piece white suite comprising a low flush WC, wash hand basin set in a vanity unit with a cupboard below and double walk-in shower with glass screen.

Outside is a block paved and gravelled seating area with potted plants and communal areas laid to lawn.
