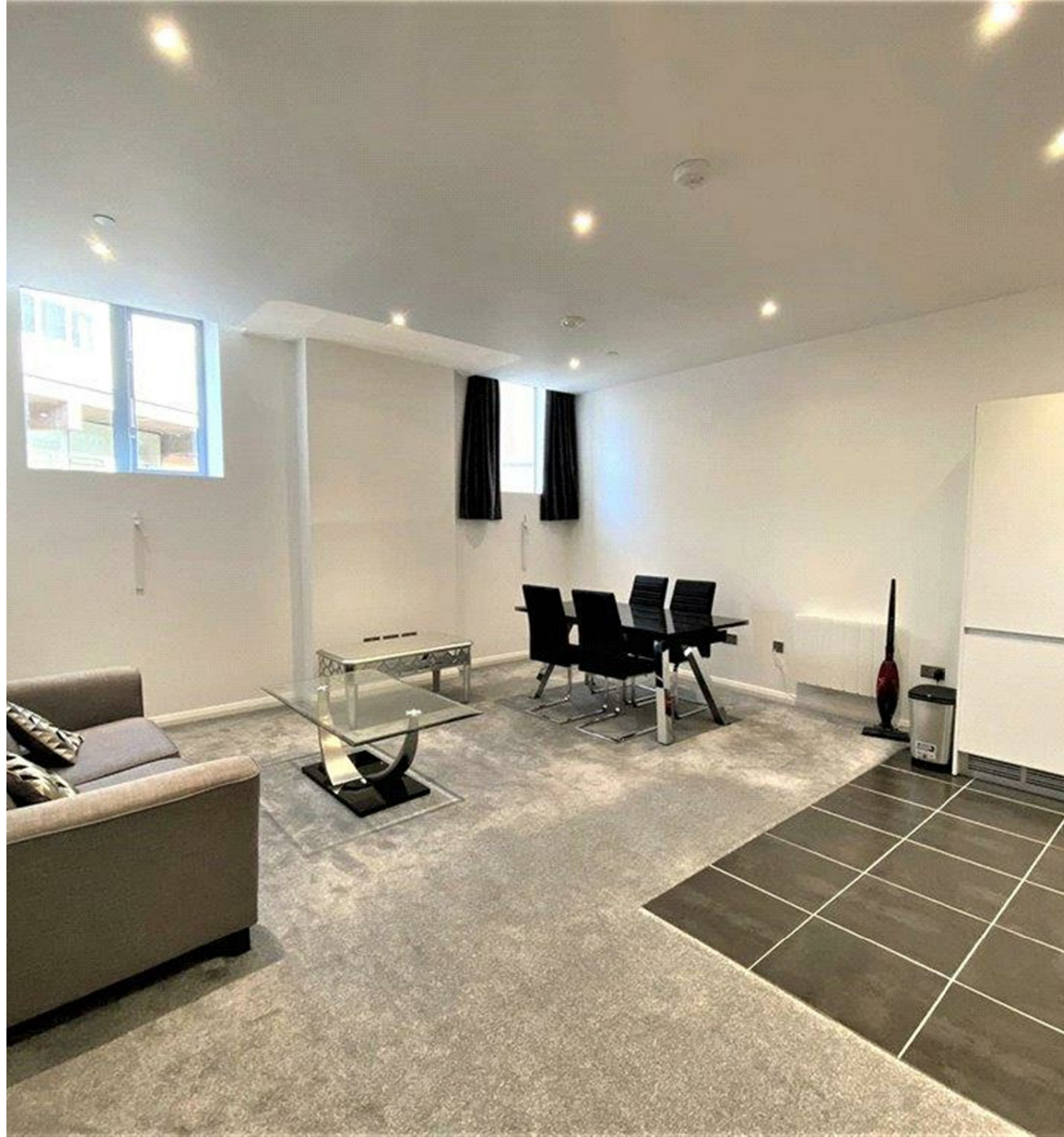

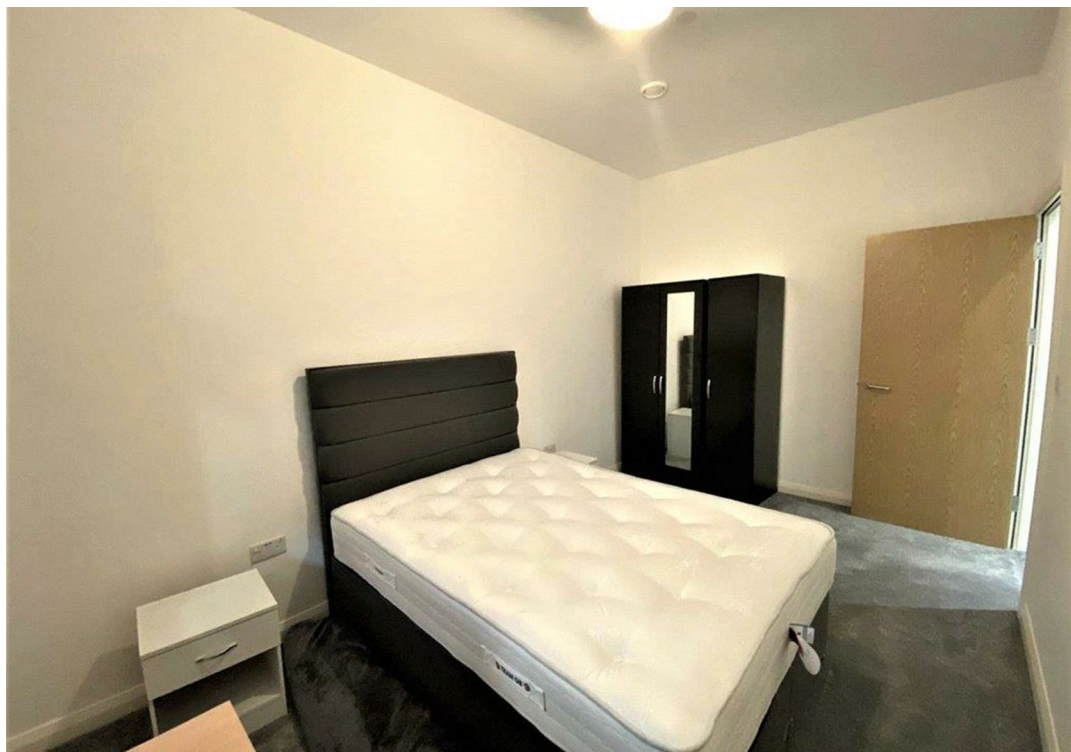

The Co-operative building has an internal park and a residents lounge for the exclusive use of tenants of this building.

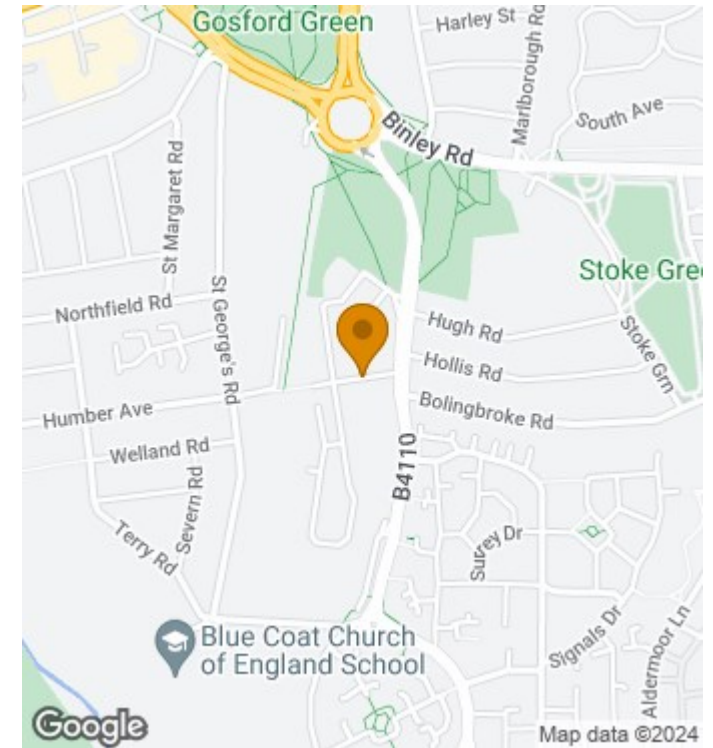




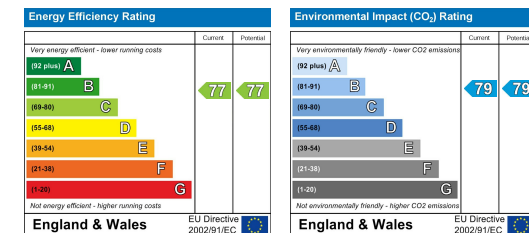




Location Map
