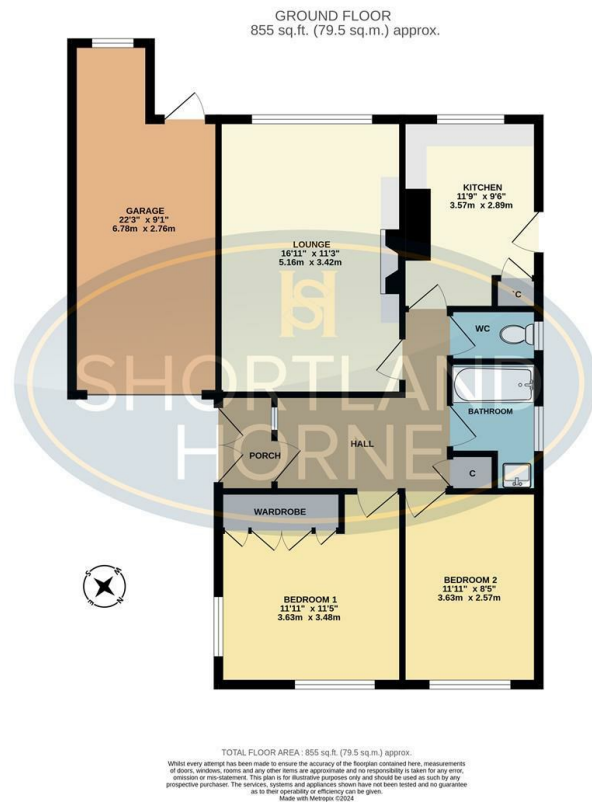


Floor Plan

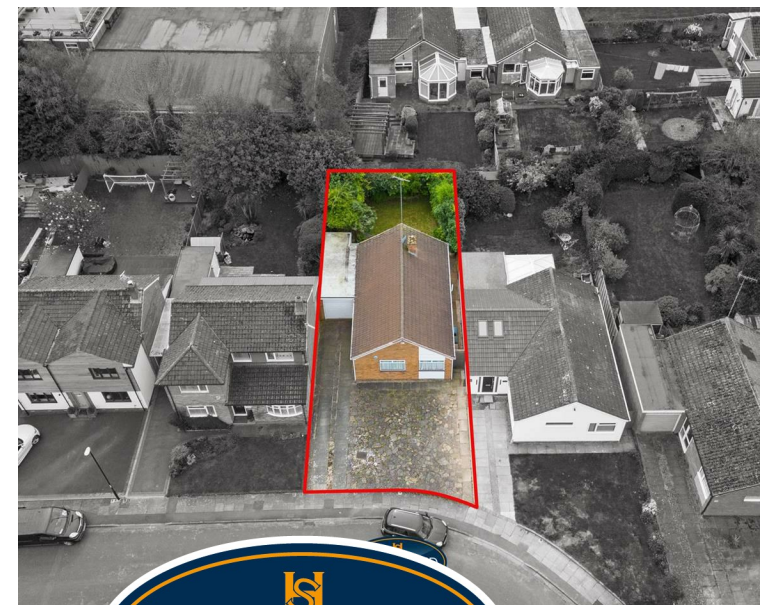
Appliances

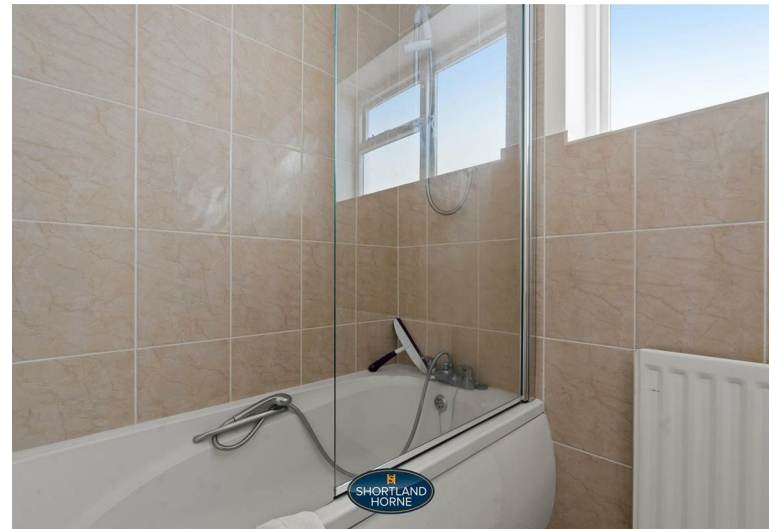
