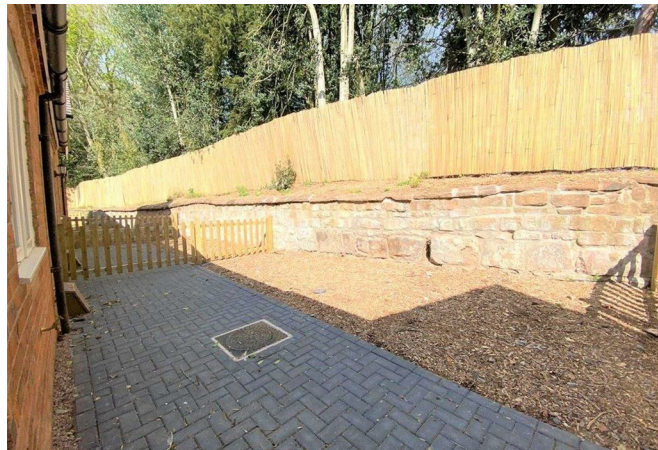

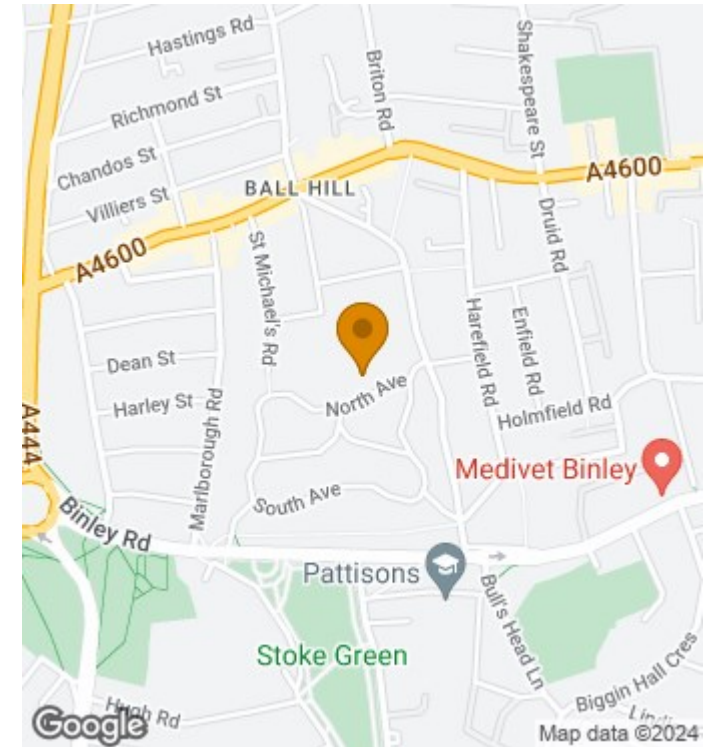




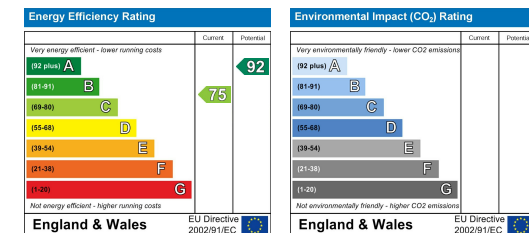




Location Map
