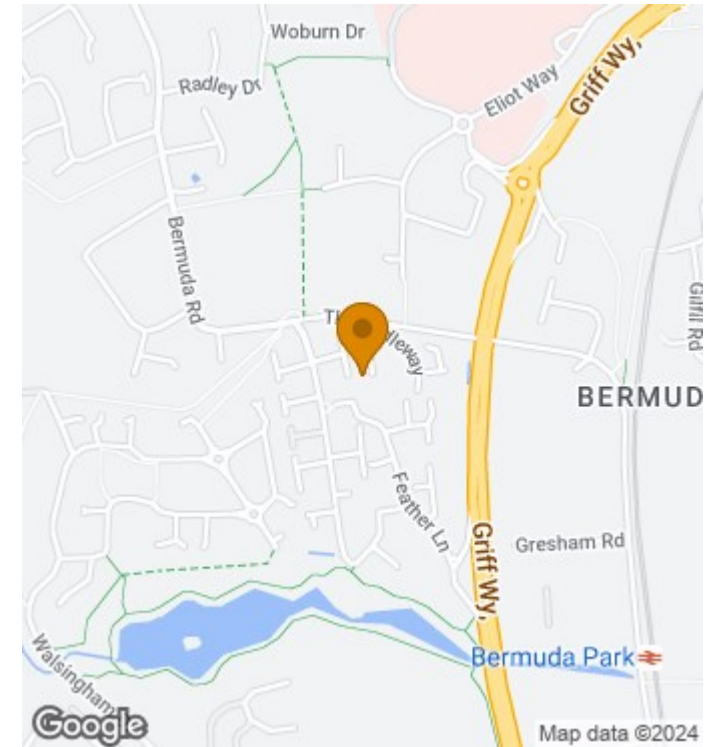




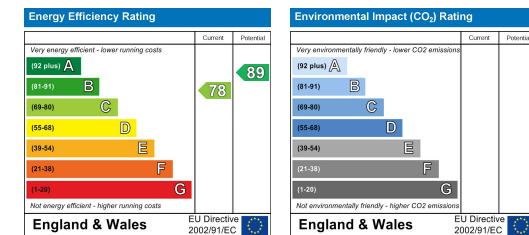




Location Map
