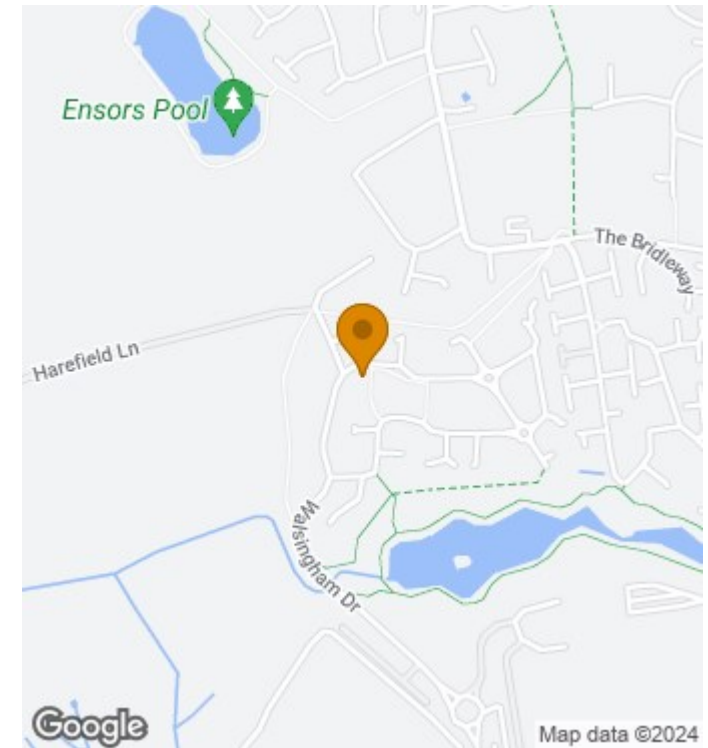








## Location Map
