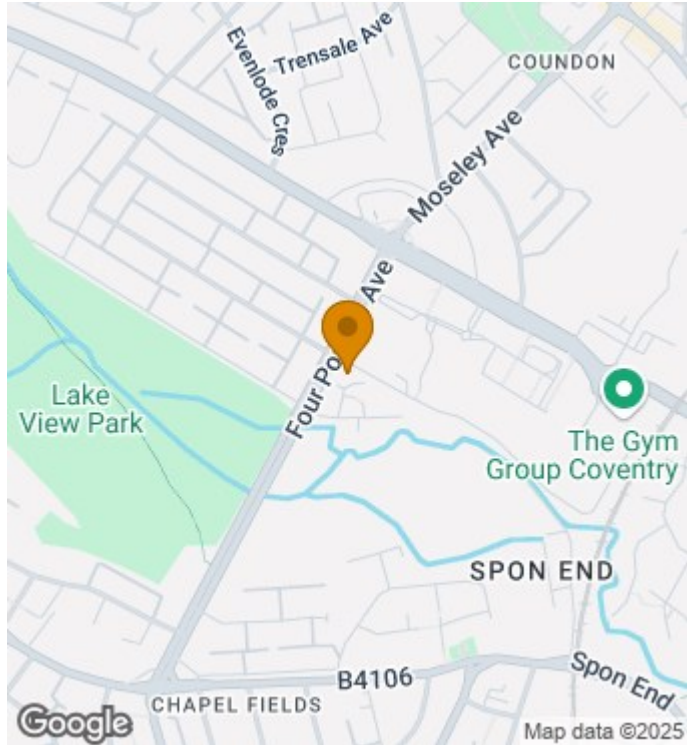




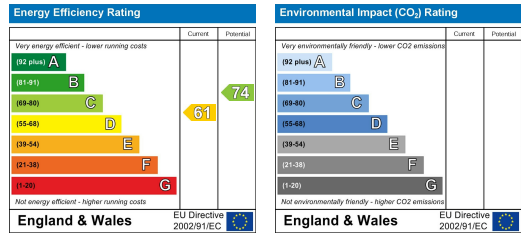




Location Map
