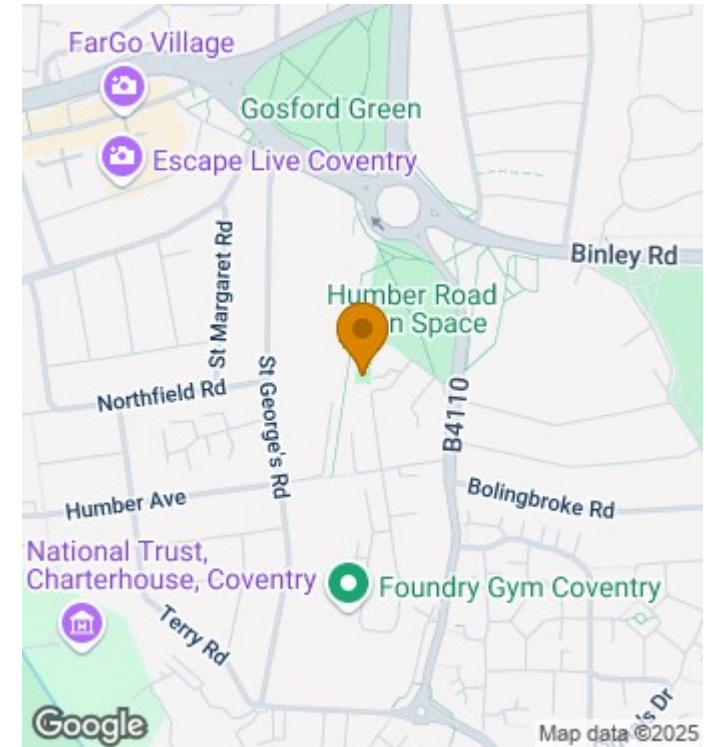
The large bedroom has an ensuite shower room which has been fully tiled. Other benefits include electric panel heaters and allocated private parking.

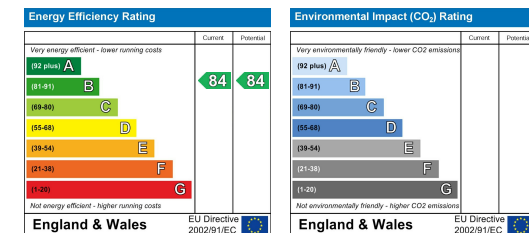




Location Map
