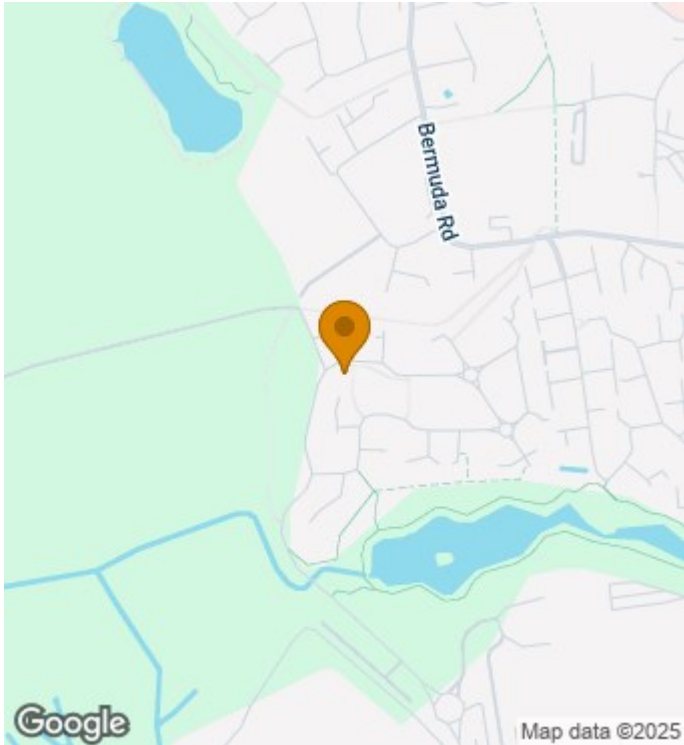


## Dimensions

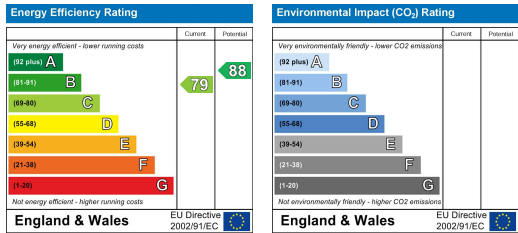


# Floor Plan
