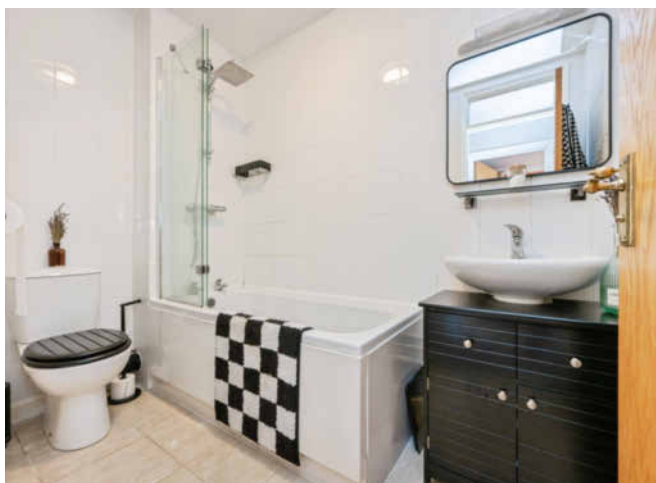


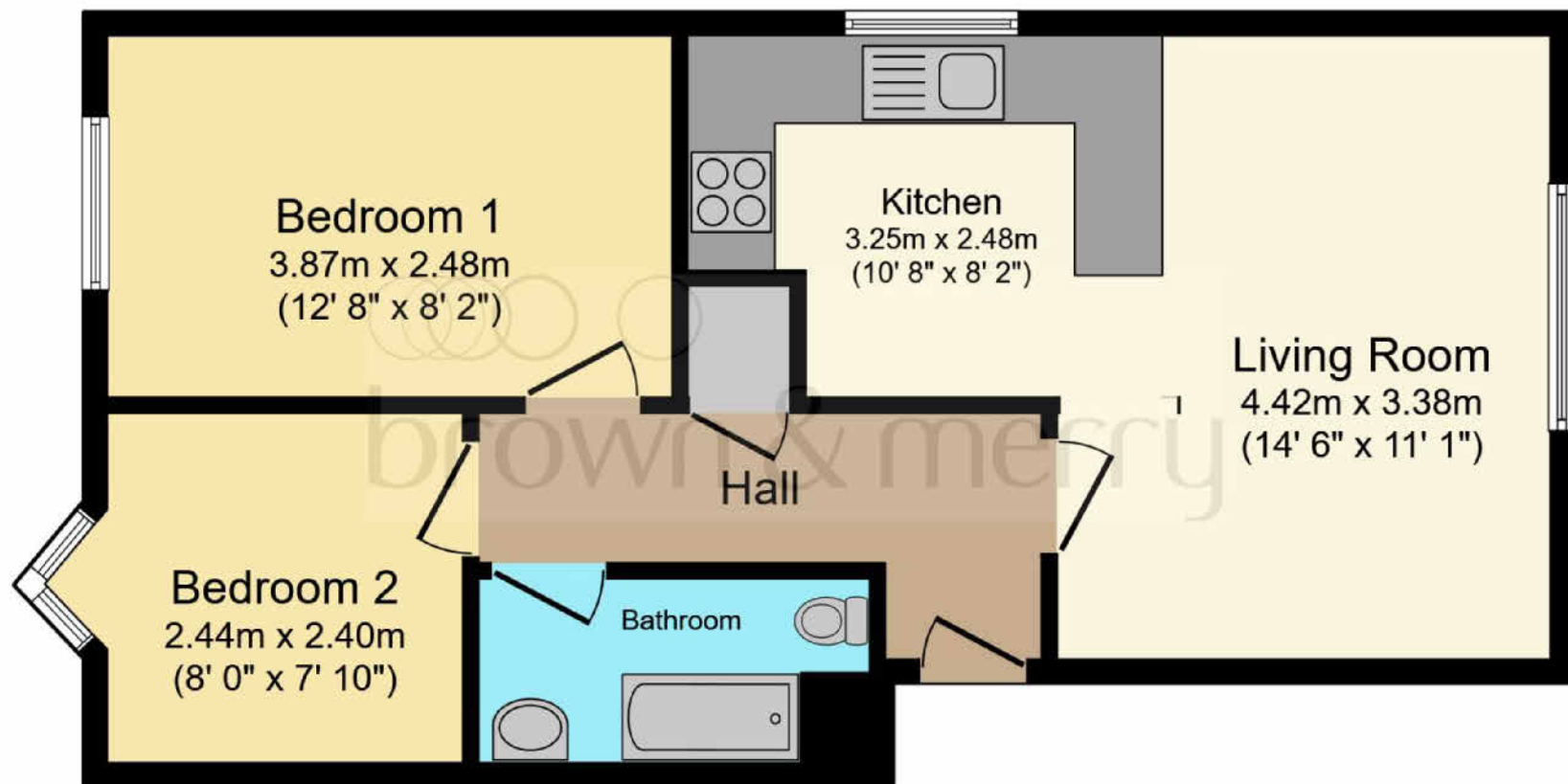
Education
