### Location

The cottages are nestled in the peaceful village of Fulletby, within the Lincolnshire Wolds ‘Area of Outstanding Natural Beauty’.



There are tourist attractions a short drive away at the nearby market town of Louth and the historic Cathedral city of Lincoln. Woodhall Spa is home to the English Golf Union and offers two golf courses including the Hotchkin, which is currently ranked the 54th best course in the world by Golf.com. To the east there are many miles of sandy coastline which include the resorts of Mablethorpe, Sutton on Sea, Ingoldmells and Skegness

The village itself benefits from views across the Wolds and is ideally situated for Walkers and cyclists with the Viking Way long distance walking path running through the village, which runs all the way from Rutland to the banks of the Humber.

### **The Cottages**

There are three cottages (1x 3 bed and 2 x 1 bed) which provide accommodation for up to 9 people in total. They each provide open plan living accommodation, private garden/patio areas with high end 'Marquis' hot tubs and parking.

The cottages have undergone a thorough and comprehensive scheme of renovation, refurbishment and landscaping works in recent years. They now provide modern fitted kitchens and shower rooms and contemporary furnishings and appliances throughout. The renovations also included new central heating, floorings, windows and doors throughout.

In addition to the cottages there is also a laundry room, store, washroom and utility area.



### **The Business**

Currently advertised on cottages.com, part of the Awaze group which includes Hoseasons, Novasol and James Villa Holidays. The cottages completed their full first year trading post Covid in 2021. Revenue information is available from the selling agent.

There is scope to increase the income by converting the laundry room and store to create an additional bedroom and shower room. There is further scope to increase the income by taking bookings in hand from the current

Mains services of water and electricity is connected. Heating is LPG with updated Worcester boilers. Drainage is to a private triton biodigester.

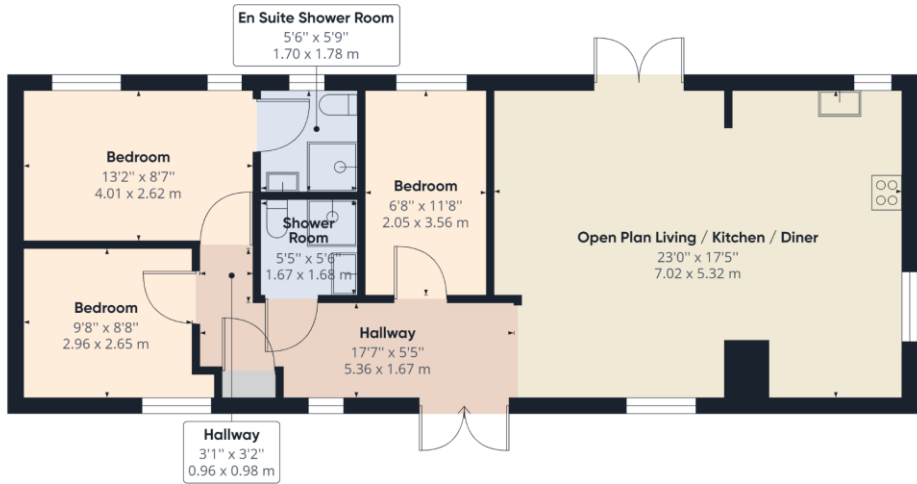

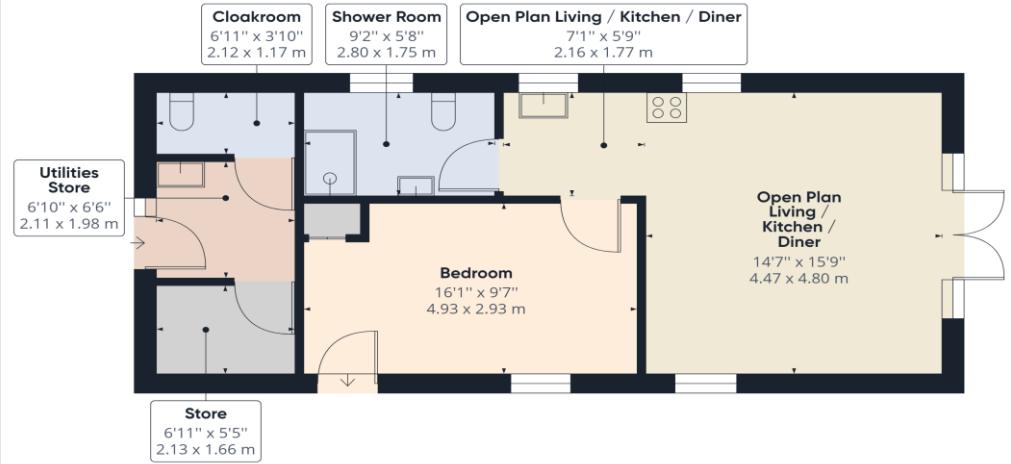




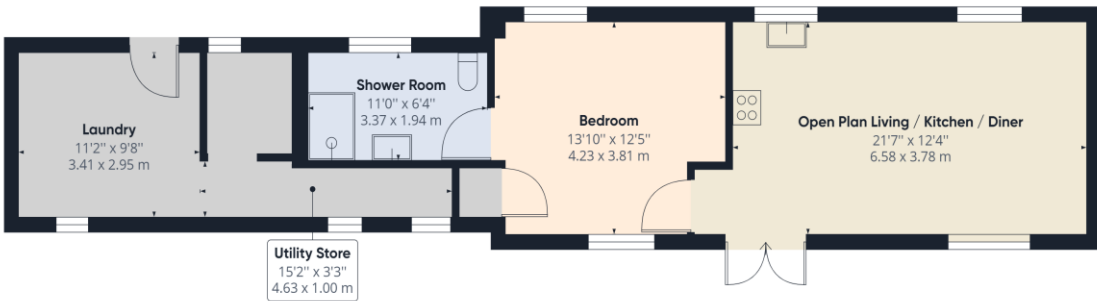
