The complex is very secure with an entry phone system and manager's office by the front door. A lift takes you to the first floor where a further landing area leads to the apartment.

Once inside, the entrance hall has 2 sets of cupboards and gives access to the lounge/diner which in turn leads to the fitted kitchen. The double bedroom has built-in wardrobes with mirrored doors. Finally, the bathroom has been converted into a shower room. Heating is provided by electric heaters and you will note the property has an excellent energy performance rating.

Outside

The complex has lovely communal gardens with mature trees, shrubs and flowers borders. There is also the benefit of limited communal on-site parking.

Lease details and charges

The property has a 99 years lease running from 1986. There is a service charge covering the costs of the manager, emergency call centre and communal areas, this charge is currently £3162.73 per annum. There is also an annual ground rent which is £275.02.
