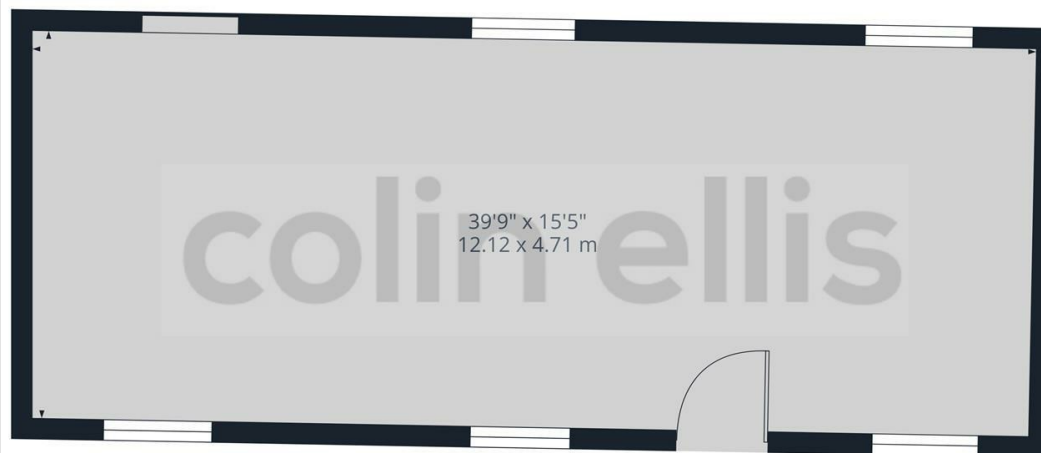
LOCATION
