1. Information and Scope of Inspection

This section tells you about the type, accommodation, neighbourhood, age and construction of the property. It also tells you about the extent of the inspection and highlights anything that the surveyor could not inspect.

All references to visual inspection refer to an inspection from within the property without moving any obstructions and externally from ground level within the site and adjoining public areas. Any references to left or right in a description of the exterior of the property refer to the view of someone standing facing that part of the property from the outside.

The inspection is carried out without causing damage to the building or its contents and without endangering the occupiers or the surveyor. Heavy furniture, stored items and insulation are not moved. Unless identified in the report the surveyor will assume that no harmful or hazardous materials or techniques have been used in the construction. The presence or possible consequences of any site contamination will not be researched.

Services such as TV/cable connection, internet connection, swimming pools and other leisure facilities etc. will not be inspected or reported on.

Description	The property under report comprises a three storey detached villa which has been extended to the rear elevation.
Accommodation	This may be summarised as follows:- Ground Level: Entrance Hallway, WC, Lounge, Lower Ground: Open Plan Dining Room / Kitchen and Sitting Area. First Floor; Master Bedroom with En-Suite Shower Room, Family Bathroom, Bedroom 2 and Bedroom 3.

Weather	It was dry and overcast at the time of our inspection.
Chimney Stacks	The chimney stack appears to be for decorative purposes only and is of brick construction, rendered externally. Associated flashings are formed in lead or a similar type material.
	Visually inspected with the aid of binoculars where appropriate.
Roofing including Roof Space	The roof is of pitched design clad with concrete interlocking tiles with tiled ridges. An inspection of the roof void was permitted, which revealed the roof structure to be of timber framed design. The roof space has been floored throughout. Where visible, insulation has been placed over the ceiling joists. It will be appreciated that we are unable to comment on any concealed or inaccessible areas.
	Sloping roofs were visually inspected with the aid of binoculars where appropriate.
	Roof spaces were visually inspected and were entered where there was safe and reasonable access, normally defined as being from a 3m ladder within the property. If this is not possible, then physical access to the roof space may be taken by other means if the Surveyor deems it safe and reasonable to do so.
	No access was obtained to any roof eaves areas.

Electricity

Mains supply connected, with the distribution board being located within the hallway cupboard.

Accessible parts of the wiring were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Gas

Mains supply connected. The gas meter is located externally to the gable end of the building.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

Water, Plumbing and Bathroom Fittings

Mains supply connected.

The downstairs toilet provides a two-piece suite comprising WC and wash-hand basin.

The family bathroom provides a three-piece suite comprising mains shower over bath, WC and wash-hand basin.

The en-suite shower room provides a three-piece suite comprising mains shower, WC and wash-hand basin.

Where visible, piping has been formed in copper and uPVC.

Accessible parts of the system were visually inspected without removing fittings. No tests whatsoever were carried out to the system or appliances. Visual inspection does not assess any services to make sure they work properly and efficiently and meet modern standards. If any services are turned off, the surveyor will state that in the report and will not turn them on.

It should be appreciated that concealed areas beneath and around baths and shower trays could not be inspected. Water spillage in these areas can result in dampness/decay and no comment can be made on inaccessible areas. Waterproof seals in sanitary areas should be checked and maintained on a regular basis.

Heating and Hot Water

Heating is provided from a Worcester Greenstar gas fired boiler which is located within the kitchen apartment. This appears to serve steel panelled radiators throughout and appears to be controlled by a thermostat positioned within the hallway. Hot water is believed to be provided from the primary heating system. The system is of a type designed to provide instantaneous hot water on demand.

Accessible parts of the system were visually inspected apart from communal systems, which were not inspected. No tests whatsoever were carried out to the system or appliances.

Drainage

Assumed gravity fed to the Local Authority main sewer.

Drainage covers etc were not lifted.

Neither drains nor drainage systems were tested.

Fire, Smoke and Burglar Alarms

Visually inspected.

No tests whatsoever were carried out to the system or appliances.

New smoke alarm standards were introduced in Scotland in February 2022 and it is likely that some properties may require additional works to meet these standards. In instances where alarms are in place, no tests whatsoever have been carried out and we cannot confirm if the system complies with the most recent regulations. Any potential purchaser should satisfy themselves as to whether the current system meets with regulations or otherwise.

Additional limits to Inspection

At the time of our inspection, the property was occupied and fully furnished with fitted floor coverings throughout. Services have not been tested.

A restricted inspection was possible only of the roof coverings from ground/ street level.


No access to the sub-floor chamber was possible at the time of our visit to the property. Within the limitations of our inspection there was no indication to suggest significant defects in this area. It will, however be appreciated that the area was not inspected and therefore no guarantees can be provided in this regard.

Our inspection was restricted to the exposed and accessible surface fabric only.

No inspection for Japanese Knotweed was carried out and unless otherwise stated for the purpose of this report, it is assumed that there is no Japanese Knotweed within the boundaries of the property or neighbouring properties.

It should be appreciated that the Home Report inspection is a non-disruptive visual inspection of the property as at the date of inspection and that we are unable to inspect parts of the property which are concealed or covered by floor coverings or contents in place at that time. Once vacant, defects may be apparent that could not be detected during our survey. Changing weather conditions can also affect aspects of the property which would not be apparent at the time of inspection.

1.1 The Surveyors





The energy efficiency rating of your home
