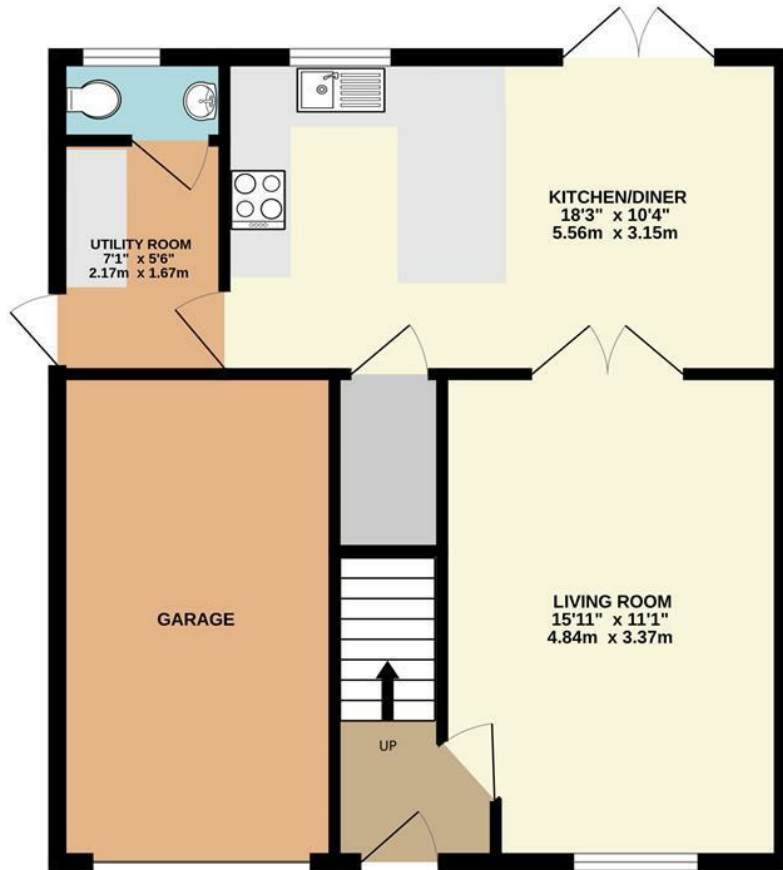

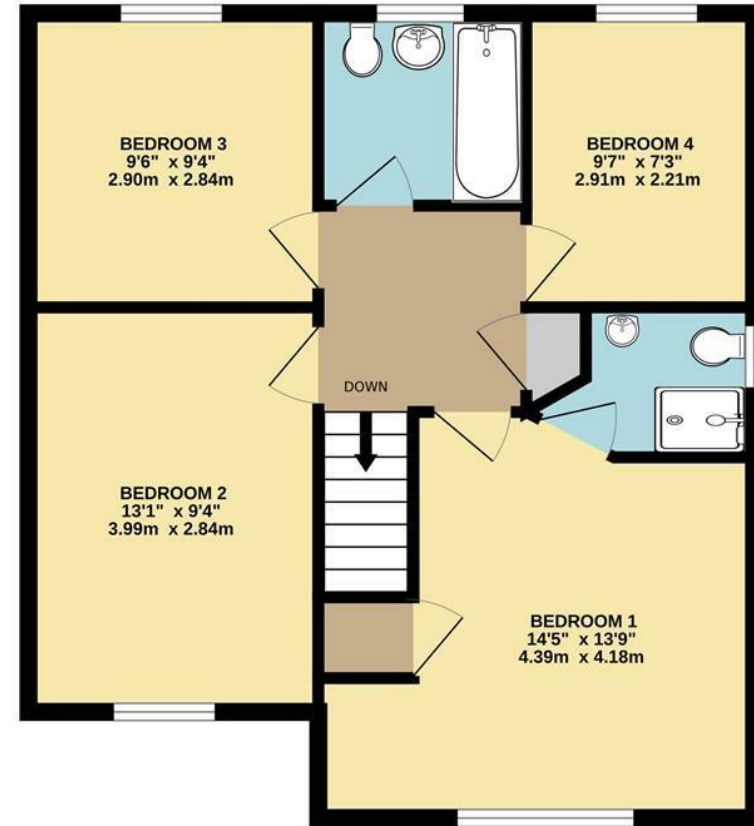

SUMMARY
