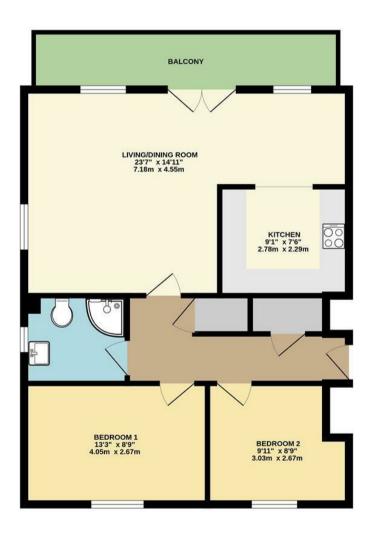

SUMMARY

A superb ground-floor flat with two double bedrooms, a large balcony, and an allocated parking space, located just moments from Exeter's Historic Quayside. The property is being sold with no onward chain and is situated in an excellent position for riverside walks, cycle routes and a wide range of independent traders, cafes, restaurants, and activity centres on Exeter Quay. The property is within walking distance to Exeter City Centre with major road links and St Thomas Train Station.

The property can be approached via steps to the front from Haven Road or via more level access within the gated development (one step into the communal hallway). There is a communal hallway and private door into the flat. The spacious accommodation comprises an entrance hall with two storage cupboards (one with plumbing for a washer/dryer), a dual aspect open plan living/dining room with double doors to the private balcony, modern fitted kitchen with a matching range of white hi-gloss wall and base units, built-in oven, hob, dishwasher, and space for a fridge/freezer. There are two double bedrooms and a modern shower room.

There is one allocated parking space in a secure underground parking area beneath the property, accessed via the double gates on Haven Road and with fob access into the parking area.

Outside are well-maintained communal grounds with gated access to the Quayside.

Early internal viewing is highly recommended.

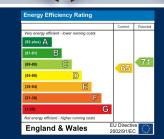
