LOCATION & DESCRIPTION

The town of Ellon is located approximately 16 miles North of Aberdeen. The town is located in Aberdeenshire and is the dominant town within the Formartine area. Ellon has a population of approximately 10,500 whilst the wider Formartine area has a population of around 43,100. 20% of Aberdeenshire's new homes are projected to be built in the Formartine area in the period 2021-25.

The Waterton Farm site extends to approximately 44 acres and is located to the East of Ellon town centre immediately adjacent to the Ellon Park & Ride facility and opposite the town's Tesco Supermarket and PFS. The A90 Trunk Road runs adjacent to the Eastern boundary and there is access to the trunk road via the existing roundabout. The Castlepark Industrial Estate is closeby as is the HQ of Brewdog, the multnational brewer and pub operator.

PLANNING

In terms of the Aberdeenshire Local Development Plan (adopted 13th January 2023) the site is allocated for Retail and Leisure Development. Allocated as opportunity CC1, the allocation is 10,000 sq.m retail and leisure uses. Interested parties should make their own enquiries on Planning matters to the Local Authority.
