LOCATION

The site is located in the Rosemount area of Aberdeen situated approximately 1 mile north of the city centre.

More specifically, the site lies on the east side of Gilcomston Park. Nearby properties are mainly residential in nature.

DESCRIPTION

Used formerly as a builder's yard, the site is made up of rough ground and accessed via a lane from Gilcomston Park. The area is predominantly residential with a car park adjoining.

PLANNING

In terms of the Local Development Plan, the property is zoned as Residential Area (H1) and lies within the Rosemount and Westburn Conservation Area.

It is considered that the site may be suitable for development subject to interested parties obtaining the necessary consents. Initial enquiries should be made by contacting the marketing agents in the first instance to discuss their proposal.
