LOCATION

The property is located within the heart of Aberdeen's city centre situated on the corner of Dee Street and Langstane Place.

The property lies just a short walking distance to excellent shopping and transport links.:-

DESCRIPTION

The property lies on a prominent corner location and comprises a 6 storey office building with parking.

Access is via a manned reception off Dee Street with 2 x 8-persons passenger lifts serving each floor.
