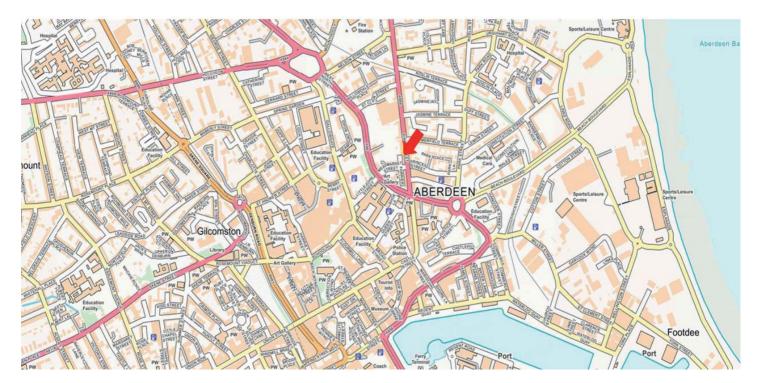

LOCATION

The subjects are located within Aberdeen City Centre in a mixed use residential/commercial area. The property is positioned on King Street, close to its junction with West North Street and the A956, which forms a main thoroughfare to Aberdeen Beach and Aberdeen Harbour. King Street forms an arterial route for traffic towards the North of the city and the University of Aberdeen.

DESCRIPTION

The subjects form part of a two-storey, basement and attic midterraced building of granite construction.

The property comprises the ground and lower ground/garden level of the building. The subjects have an attractive timber shopfront with central door. Internally, the ground floor provides sales area, which benefits from an abundance of natural light. A stone stair gives access to the lower level which provides further sales/display areas together with access to an attractive exclusive garden.
