This beautifully presented 3 bedroom mid terraced house is situated in the popular village of Rusthall and benefits from 2 reception areas and kitchen/breakfast room.

ACCOMMODATION

Ground Floor:

Front door leading into the Entrance Hall leading to the stairs to the second floor. To the left of the Entrance Hall is the Lounge with a feature fire place and bay window leading into a family room/dining second reception area with storage and shelving. There is a good sized Kitchen/Breakfast Room with a range of wall and base units for storage as well as built in storage, wooden worktops, integrated stainless steel oven/grill and gas hob, washing machine, dishwasher, freestanding fridge/freezer and room for a kitchen table and double doors leading onto the patio and garden.

First Floor:

There are three Bedrooms, two Double Bedrooms, the smaller one overlooking the rear of the property, the master bedroom at the front of the property, both come with built in storage and a smaller bedroom/study with storage and shelving. A Family Bathroom suite comprising a WC, wash hand basin, panel bath with shower screen and shower over and plenty of storage cupboards.

OUTSIDE

To the rear of the property there is a private mature Garden with patio and a plant covered arbour for shade and seating area. There is a pretty mature border with plenty of shrubs against a good size space of lawn. At the bottom end of the Garden is a shed for storing garden equipment.



SITUATION

The property is located in the popular village of Rusthall, which has local shopping facilities within an easy walk. The main town of Tunbridge Wells is approximately one-and-a-half miles distance and includes many cafes, bistros and restaurants, the historic Pantiles, old High Street and Royal Victoria Place shopping mall and the Calverley Road precinct, with more specialist shops, cafés, bistros and restaurants in the High Street and Pantiles areas of the town. There is a choice of stations at either Tunbridge Wells or High Brooms providing fast and frequent train services to London and the south coast. The area is also well served with a variety of schools, both state and independent, for children of all ages and recreational amenities including the Tunbridge Wells Sports & Indoor Tennis Centre on St John's Road, local parks, golf, rugby and cricket clubs, whilst on the outskirts of the town is the Knights Park Leisure Centre with its multiscreen cinema, tenpin bowling complex and a private health club.
