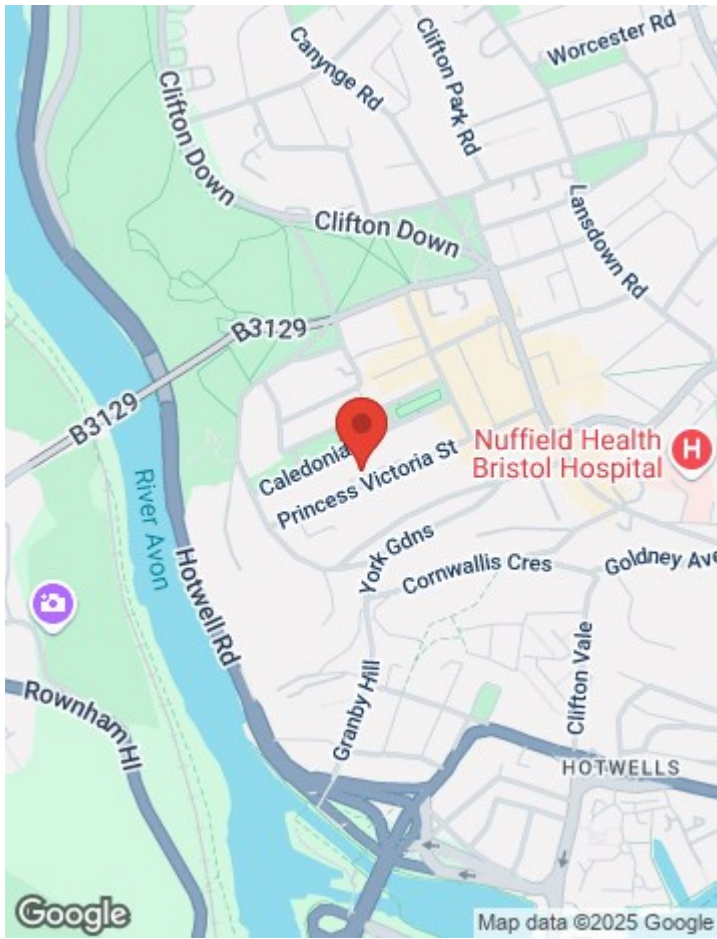
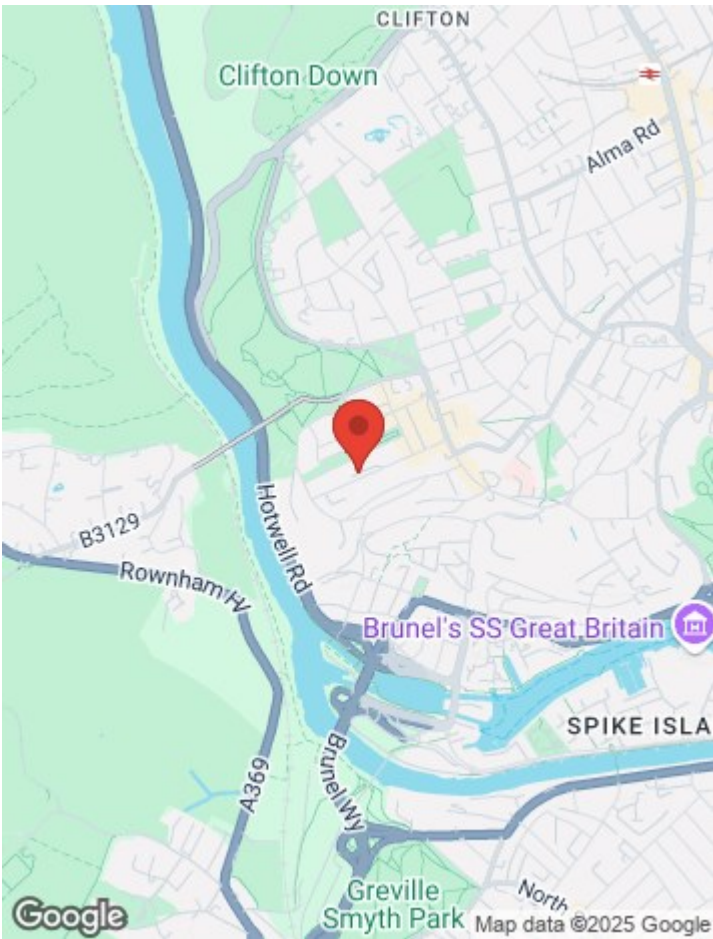
FIRST FLOOR
