#### LOCATION

There are a variety of small, independent retailers close by, with national retailers such as M&S slightly further along the High Street.


Maldon is an attractive coastal town approximately 10 miles east of Chelmsford and 18 miles south west of Colchester.

#### DESCRIPTION

The property comprises of a ground floor lock up shop, and a self-contained one bedroom first floor flat. The shop has an internal frontage of 24' with small pane glazed windows fronting onto the High Street.

Internally the property benefits from attractive exposed timber beams, part laminate wood flooring, inset ceiling spotlights and there is gas central heating by radiators. Towards the rear of the unit is a small storage area and a W.C. With wash hand basin and electric water heater.

The flat is accessed from the rear and is in good decorative order, benefitting from a fitted kitchen, gas central heating and exposed beams. There is a rear courtyard garden.


