Situation

Directions

From the direction of Carmarthen proceed along the A484 roadway and access to the land is along Pibwrlwyd flats where a right hand turn just before the former filling station now 'Beee Hire' van and car storage leads to the land. A location plan is attached to the details.

Description

Conveniently located to the A484 roadway this very accessible parcel of land extends to some 20.87 acres or thereabouts and is divided into three enclosures. Laid to pasture the land is currently used for both grazing and cropping purposes and offers a productive parcel of land. Benefitting from shared access along a tarmacadam road being ideally suited to purchasers looking for a supplementary parcel of land to expand their holding. Alternatively being equally suited to those parties looking for a parcel of land for amenity or leisure use. We would advise that the vendor would consider splitting the land into smaller enclosures if required. Given the proximity of the sub-station that the land maybe suitable for solar subject to gaining the necessary consents.

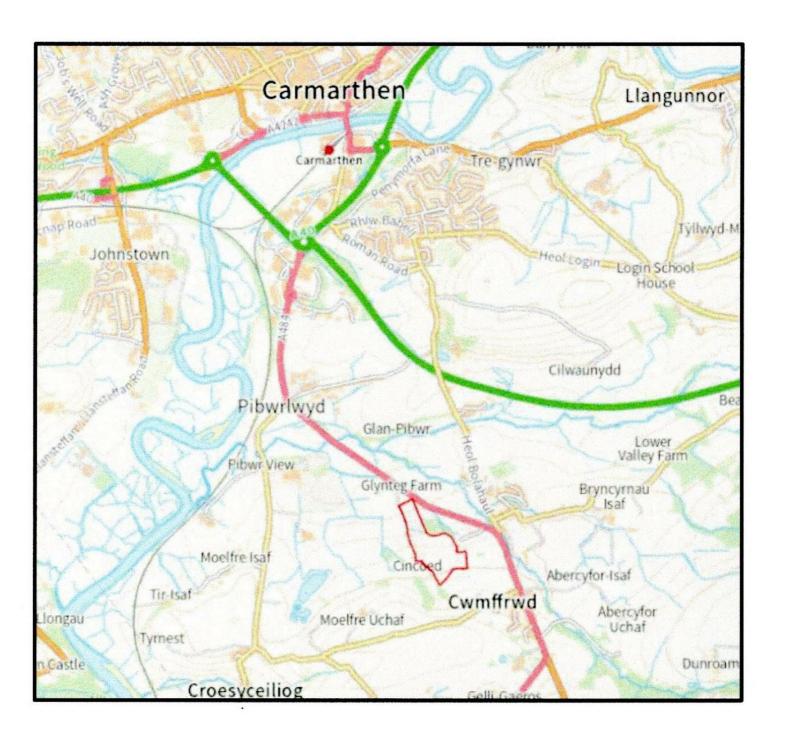

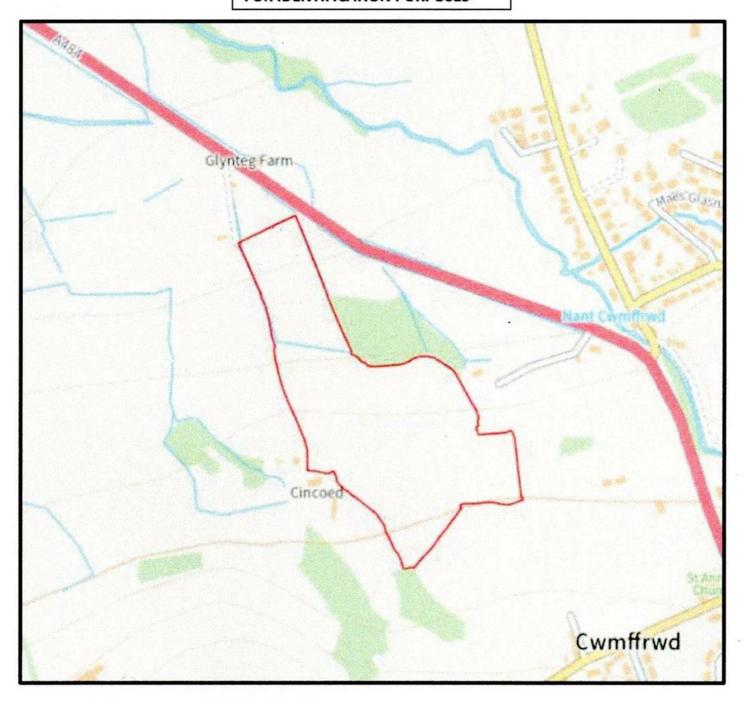
