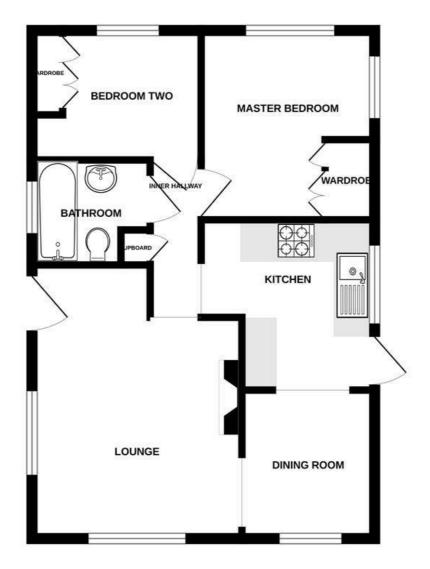






Floor Plan
