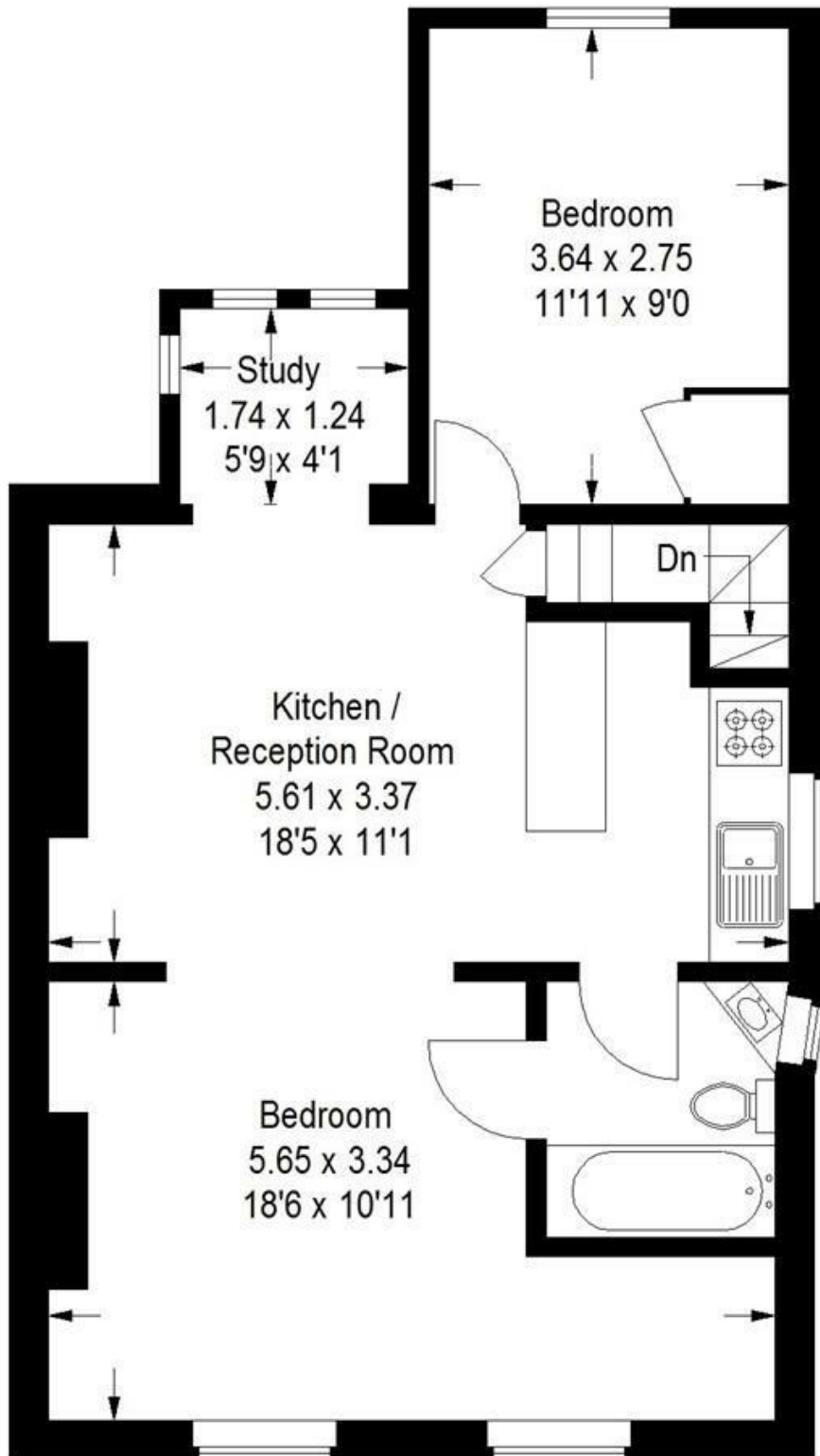
Outside there is a front garden with a wall and a range of shrubs.

The property is offered unfurnished and available immediately.



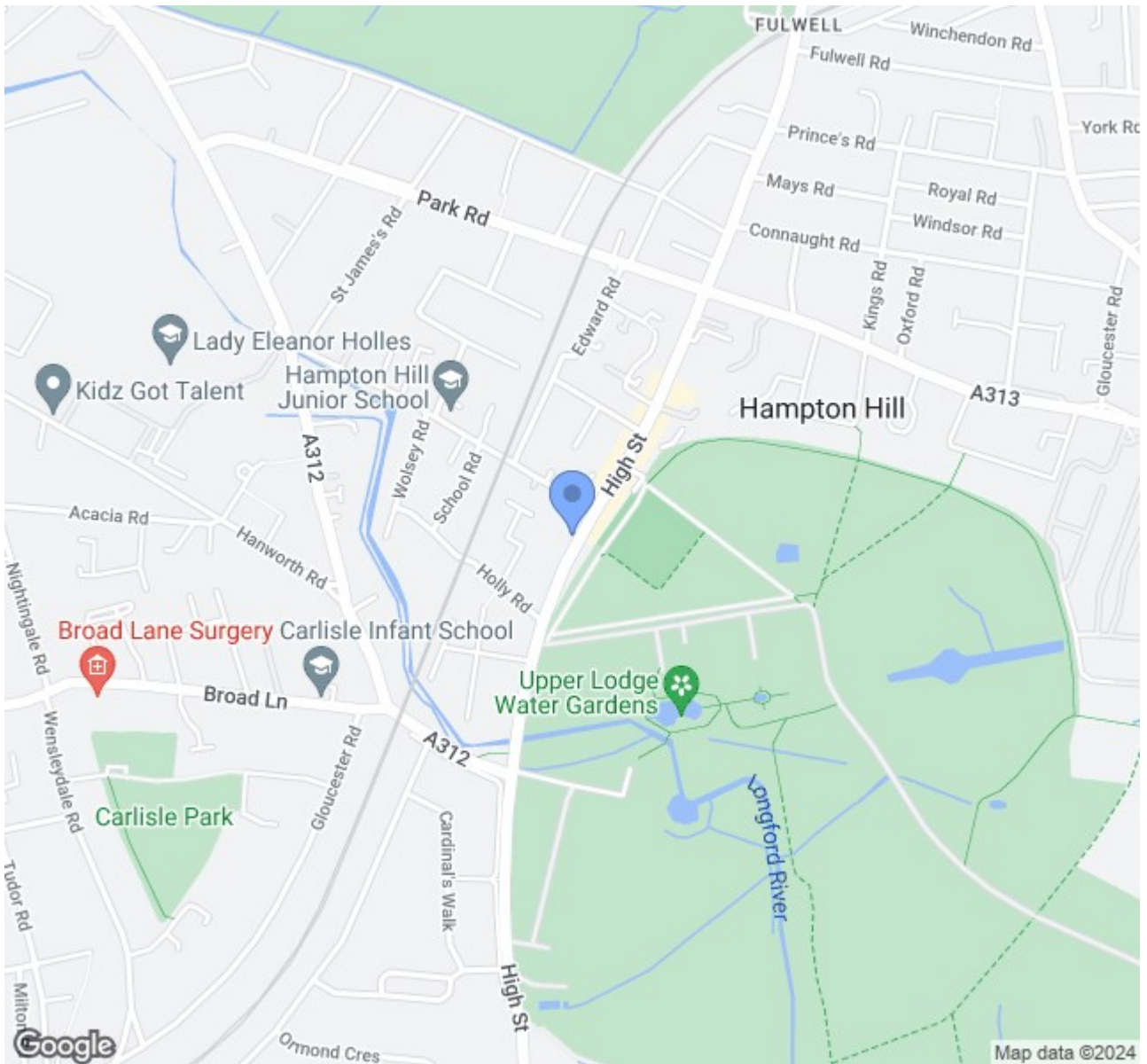




## First Floor
