An extremely charming traditional stone two-bedroom ground floor flat with private garden, peacefully nestled yet centrally located in the heart of the picturesque Borders town of Peebles.



#### DESCRIPTION:

Dating back to the mid-1800s, this characterful property exudes timeless charm, enhanced by tasteful interiors and a warm, welcoming ambience throughout. Well-presented in good decorative order, the home offers a well-planned internal layout encompassing approximately 638 square feet of comfortable, single-level living space. With its blend of traditional allure with modern convenience, and views over the Eddleston water, 11 Bridgegate is a delightful abode with broad appeal, sure to captivate a variety of buyers. Early viewing is highly recommended to fully appreciate everything this wonderful property has to offer.

With attractive and welcoming approach through the private garden, the internal accommodation begins with an inviting entrance porch, which opens into a spacious, warm and welcoming hallway. The relaxing sitting room enjoys a front-facing window that offers delightful views over Eddleston water, and adding a touch of character, an original iron fireplace—though decorative only—serves as a charming focal point. Located at the rear of the property, the dining kitchen is well-appointed with a variety of wall and base units, complemented by contrasting worktop surfaces and a classic Belfast sink. Adding to its charm is an electric Rangemaster farmhouse cooker, seamlessly blending character with modern functionality, whilst space and connections include a washing machine, dishwasher, and a fridge-freezer. The dining area is bathed in natural light, via a skylight and two elevated rear-facing windows, creating an ideal setting for gatherings with family and friends. A side door opens to a compact yet practical outdoor area, which also provides access to the property externally. The property offers two comfortable bedrooms, both accessed from the spacious central hallway. The larger bedroom is peacefully positioned at the rear of the home, while the second benefits from soothing waterside views, creating a tranquil space. This versatile room could equally serve as a home office or study, depending on individual requirements. Completing the accommodation is a modern three-piece shower room including a WC, wash hand basin, a corner shower unit, and a rear facing opaque window allowing in the natural light.

#### OUTSIDE:

Externally, the charm continues with a private front garden, enclosed by original stone walling and traditional iron fencing with an access gate. This delightful outdoor space is thoughtfully designed with two areas of artificial lawn, bordered by well-maintained, mature flower beds. A vibrant array of seasonal plantings adds colour and character throughout the year, creating an idyllic setting for relaxation—perfectly complemented by the soothing sounds of the nearby Eddleston Water. As previously noted, an outdoor area to the rear of the property provides convenient external access. Parking is available nearby on St Michael's Bank, as well as on surrounding streets.

#### LOCATION:

The Royal Burgh of Peebles is a thriving market town and the third largest town in the Borders with a population of around 9,000. Peebles is an ideal location for those looking to enjoy the country lifestyle taking full advantage of the fishing, hillwalking, mountain biking, horse riding, and golf facilities that the area has to offer. There is a swimming pool, and the Gytes Leisure Centre offers a wide variety of leisure activities to suit adults and children. Glentress Forest and its popular mountain biking routes are approximately 4 miles east of Peebles offering excellent biking facilities. For those who enjoy the creative arts, the Eastgate Theatre & Arts Centre showcases local and international musical and artistic talent throughout the year and there are a number of popular festivals throughout the year including the week-long Beltane Festival which is steeped in the history of Peebles and follows a traditional format, an Arts Festival, Agricultural Festival, Rugby Sevens, and TweedLove Bike Festival, to name just a few. The High Street of Peebles has a wide selection of independent retailers and highly regarded restaurants as well as a number of high street favourites. The town also has a health centre, dentists, vets, banks, and supermarkets as well as primary and secondary schools. Peebles is ideally situated within commuting distance of Edinburgh which can be reached by private or public transport. There is a frequent bus service running to and from Edinburgh as well as services for Biggar, Galashiels, and nearby local towns. The A703 gives easy access to the Edinburgh City Bypass for onward travel to many destinations and Edinburgh Airport for UK or overseas travel.

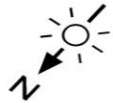

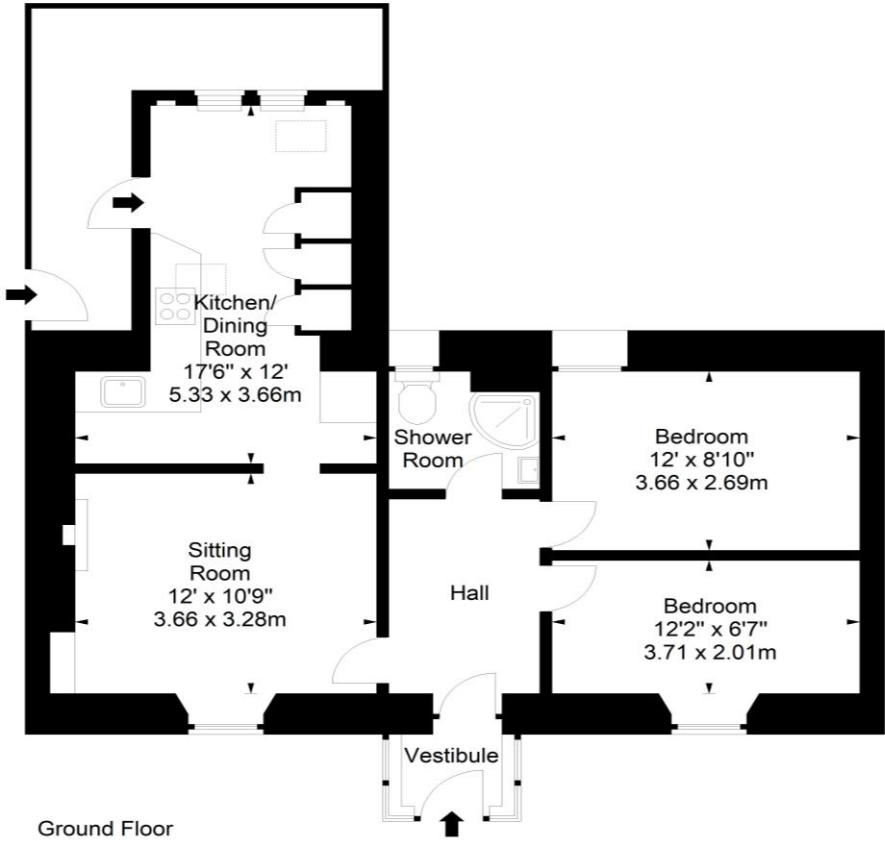


Approx. Gross Internal Area
