

Positioned within a desirable modern development, a fantastic, three-bedroom midterraced house with private rear garden pleasantly positioned on the southern side of the picturesque Borders town of Peebles.











DESCRIPTION:

Recently redecorated with fresh, crisp interiors throughout, this property offers comfortable accommodation spanning 736 square feet, featuring a practical and well-designed layout over two levels. Located approximately a twenty-minute walk from the town centre and well-served by a local bus route, the property is also within easy reach of both primary and secondary schools, making it an ideal choice for families, first-time buyers, or those looking to downsize. Early viewing is highly recommended to fully appreciate all this home has to offer.

The well-appointed internal accommodation begins with a welcoming entrance hallway, featuring a convenient guest cloakroom/WC and a staircase leading to the upper floor. Situated at the front of the property, the modern fully integrated kitchen boasts a range of fitted wall and base units, a stainless steel sink, and laminated work surfaces, all enhanced by a stylish tiled splashback. Integrated appliances include an electric oven, gas hob, cooker hood, dishwasher, washing machine, and fridge freezer. There is also ample space for a breakfast table and chairs, making it ideal for casual dining. Positioned at the rear of the property, the bright and spacious sitting room offers a relaxing atmosphere, featuring a rear-facing window and French doors that provide seamless access to the private garden. There's ample space for a dining table and chairs, ideal for entertaining family and friends, while a handy under-stair cupboard adds practical storage. The first floor features a landing with a useful linen cupboard and access to the loft space. At the front of the property is the charming principal bedroom, complete with a built-in wardrobe and a window overlooking Kittlegairy Road. To the rear, there is a bright second double bedroom with a rear-facing window, as well as a versatile single bedroom which could equally serve as a home office or nursery, also benefiting from a rear-facing window. Completing the accommodation is a partially tiled bathroom fitted with a WC, wash hand basin, and a panelled bath with a mains shower over, along with an opaque window to the front for natural light.


OUTSIDE:

Externally, there are private garden grounds to the front and rear of the property. To the front, the open-style garden is laid to lawn and features a paved pathway leading to the entrance. At the rear, the sunny, south-facing garden is also laid to lawn and enhanced by a paved patio area, ideal for alfresco dining and relaxing during the warmer months. A garden shed offers excellent outdoor storage, while the space is fully enclosed by timber fencing with a gate providing convenient rear access. The development also benefits from ample resident and visitor parking.

LOCATION:

The Royal Burgh of Peebles is a thriving market town and the third largest town in the Borders with a population of around 9,000. Peebles is an ideal location for those looking to enjoy the country lifestyle taking full advantage of the fishing, hillwalking, mountain biking, horse riding, and golf facilities that the area has to offer. There is a swimming pool, and the Gytes Leisure Centre offers a wide variety of leisure activities to suit adults and children. Glentress Forest and its popular mountain biking routes are approximately 4 miles east of Peebles offering excellent biking facilities. For those who enjoy the creative arts, the Eastgate Theatre & Arts Centre showcases local and international musical and artistic talent throughout the year and there are a number of popular festivals throughout the year including the week-long Beltane Festival which is steeped in the history of Peebles and follows a traditional format, an Arts Festival, Agricultural Festival, Rugby Sevens, and TweedLove Bike Festival, to name just a few. The High Street of Peebles has a wide selection of independent retailers and highly regarded restaurants as well as a number of high street favourites. The town also has a health centre, dentists, vets, banks, and supermarkets as well as primary and secondary schools. Peebles is ideally situated within commuting distance of Edinburgh which can be reached by private or public transport. There is a frequent bus service running to and from Edinburgh as well as services for Biggar, Galashiels, and nearby local towns. The A703 gives easy access to the Edinburgh City Bypass for onward travel to many destinations and Edinburgh Airport for UK or overseas travel.











SERVICES:

DEVELOPMENT FACTOR:

The development's communal areas are managed by Scottish Woodlands Trust, with an annual factoring charge of approximately £255 payable in 2024.










Kittlegairy View, Peebles, Scottish Borders, EH45 9LZ
