Nestled in the picturesque Borders town of Peebles, a fantastic two-bedroom first-floor flat set within a well-established residential area, just a short stroll from the vibrant and well-regarded High Street.



### DESCRIPTION:

Beautifully presented with fresh neutral décor and new flooring throughout, this charming property, dating back to the 1930's, offers 697 square feet of comfortable accommodation complemented by a generous private garden. Boasting a central location close to an excellent range of amenities, including shops, bars, restaurants, and inviting coffee shops, further enhanced by nearby parks, picturesque riverside walks, and cycle paths, this flat is certain to appeal to a wide variety of buyers. Early viewing comes highly recommended.

Accessed via a private main entrance at ground level to the side of the property, the accommodation opens into a welcoming cloak area, with a staircase rising to the first-floor landing with useful storage cleverly incorporated beneath. Positioned at the front, the sitting room boasts a spacious and inviting ambiance, enhanced by a large window bathing the space in natural light and a centrally positioned feature electric fire. Accessed from the sitting room, the kitchen features a range of timeless wall and base units, complemented by contrasting worktops with matching splashback. Integrated appliances include an electric oven and gas hob, with designated space and provisions for a washing machine and fridge freezer. The property boasts two bedrooms, including a well-proportioned principal bedroom with a front-facing window that fills the room with natural light, and a double bedroom quietly positioned to the rear. Completing the accommodation, the bathroom room is positioned to the rear featuring an opaque window for privacy, and includes a WC, wash hand basin, and a panelled bath with shower over.

### OUTSIDE:

Externally; the property benefits from a generous private garden area to the rear. Predominantly laid to lawn and arranged over tiers, the garden is enhanced by areas of mature shrubbery and includes a timber shed providing useful storage. Enclosed by stone walling and timber fencing, this versatile outdoor space offers excellent potential to be shaped to individual taste, with ample room for features such as a vegetable patch, flower beds, or a patio area ideal for alfresco moments during the warmer months.

### LOCATION:

The Royal Burgh of Peebles is a thriving market town and the third largest town in the Borders with a population of around 9,000. Peebles is an ideal location for those looking to enjoy the country lifestyle taking full advantage of the fishing, hillwalking, mountain biking, horse riding, and golf facilities that the area has to offer. There is a swimming pool, and the Gytes Leisure Centre offers a wide variety of leisure activities to suit adults and children. Glentress Forest and its popular mountain biking routes are approximately 4 miles east of Peebles offering excellent biking facilities. For those who enjoy the creative arts, the Eastgate Theatre & Arts Centre showcases local and international musical and artistic talent throughout the year and there are a number of popular festivals throughout the year including the week-long Beltane Festival which is steeped in the history of Peebles and follows a traditional format, an Arts Festival, Agricultural Festival, Rugby Sevens, and TweedLove Bike Festival, to name just a few. The High Street of Peebles has a wide selection of independent retailers and highly regarded restaurants as well as a number of high street favourites. The town also has a health centre, dentists, vets, banks, and supermarkets as well as primary and secondary schools. Peebles is ideally situated within commuting distance of Edinburgh which can be reached by private or public transport. There is a frequent bus service running to and from Edinburgh as well as services for Biggar, Galashiels, and nearby local towns. The A703 gives easy access to the Edinburgh City Bypass for onward travel to many destinations and Edinburgh Airport for UK or overseas travel.

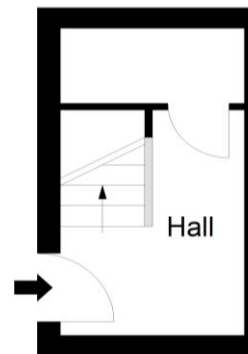
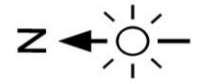




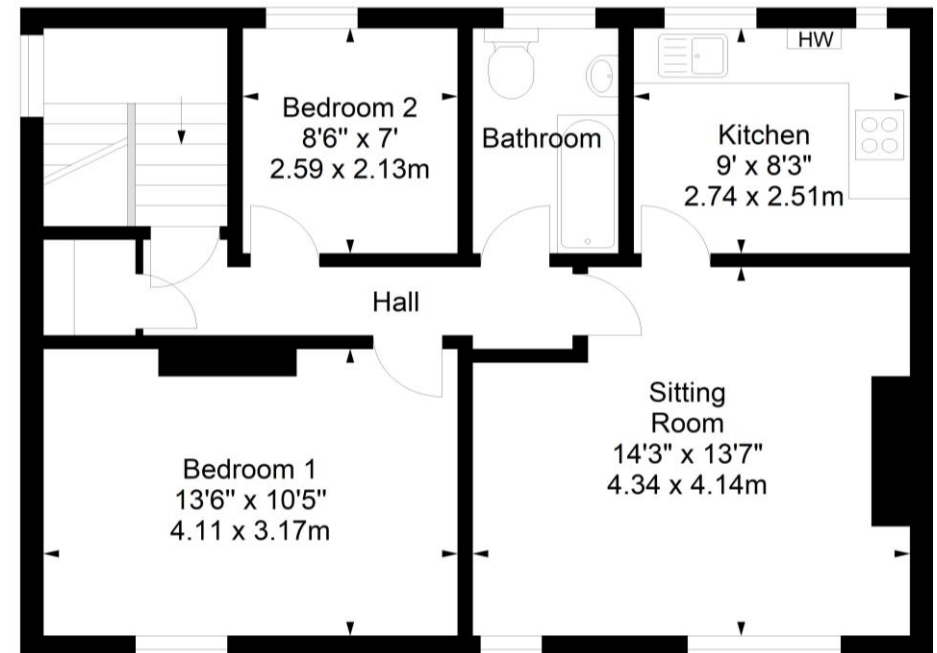
