Occupying a fantastic central location, a charming three-bedroom semi-detached family home with private front and rear gardens, boasting wonderful views over the picturesque Borders town of Peebles.



DESCRIPTION:

Built in the 1950's, the property is presented in good decorative order throughout with stylish interiors whilst offering a generous layout across three comfortable floors, extending to approximately 1270 square feet including a roomy basement with external access. Just a short stroll from the bustling High Street, this home provides easy access to a wide range of local amenities, as well as nearby parks, scenic riverside walks, and cycle paths on the doorstep. With so much to offer, this property is ideally suited to a variety of buyers, and early viewing comes highly recommended.

With an inviting approach through the private front garden, the property opens into a welcoming hallway, complete with a staircase to the upper floor and a convenient guest WC. The relaxing sitting room features dual aspect windows to the front and rear framing pleasant views while bathing the space in natural light. The kitchen, although compact is perfectly formed with a good range of modern wall and base units with contrasting worktops and splashback. Integrated appliances include a gas hob, electric oven, and a fridge. Semi-open plan to the kitchen with a split level, the dining room is located at the rear and offers the perfect spot for family gatherings and entertaining friends. On the first floor, there is a hallway landing with storage cupboard, and two comfortable double bedrooms, one situated to the rear, and the other to the front, which benefits from a walk-in cupboard. Also located to the rear on this level is the family bathroom, incorporating a WC, wash hand basin, and a panelled bath with mains shower over. An opaque rear-facing window allows natural light to filter through. Rising to the second floor, a landing area leads to the relaxing principal bedroom, which enjoys two rear-facing windows offering a fantastic outlook over the rooftops and hills beyond, along with a Velux window to the front. The principal bedroom also features a fitted wardrobe and additional storage space within the eaves. Accessed externally at the rear, there is a useful basement area currently used as additional storage space and utility area, benefiting from power and light.

OUTSIDE:

Externally, the property benefits from private, low-maintenance garden grounds to both the front and rear. At the front, there is a paved area bordered by a fantastic array of mature plantings fully bound by stonewalling and iron fencing. The rear garden enjoys delightful views and features a timber-decked area along with a spacious paved patio, providing ample room for outdoor dining and lounge furniture, the perfect setting for alfresco entertaining and relaxation during the warmer months. A staircase to the side leads down to a gated side entrance, offering both privacy and convenience and also leads to the basement rooms which benefit from power and light, plumbing for a washing machine, as well as fitted shelving. and also provides access. Parking is available on street at the front of the property.

LOCATION:

The Royal Burgh of Peebles is a thriving market town and the third largest town in the Borders with a population of around 9,000. Peebles is an ideal location for those looking to enjoy the country lifestyle taking full advantage of the fishing, hillwalking, mountain biking, horse riding, and golf facilities that the area has to offer. There is a swimming pool, and the Gytes Leisure Centre offers a wide variety of leisure activities to suit adults and children. Glentress Forest and its popular mountain biking routes are approximately 4 miles east of Peebles offering excellent biking facilities. For those who enjoy the creative arts, the Eastgate Theatre & Arts Centre showcases local and international musical and artistic talent throughout the year and there are a number of popular festivals throughout the year including the week-long Beltane Festival which is steeped in the history of Peebles and follows a traditional format, an Arts Festival, Agricultural Festival, Rugby Sevens, and TweedLove Bike Festival, to name just a few. The High Street of Peebles has a wide selection of independent retailers and highly regarded restaurants as well as a number of high street favourites. The town also has a health centre, dentists, vets, banks, and supermarkets as well as primary and secondary schools. Peebles is ideally situated within commuting distance of Edinburgh which can be reached by private or public transport. There is a frequent bus service running to and from Edinburgh as well as services for Biggar, Galashiels, and nearby local towns. The A703 gives easy access to the Edinburgh City Bypass for onward travel to many destinations and Edinburgh Airport for UK or overseas travel.

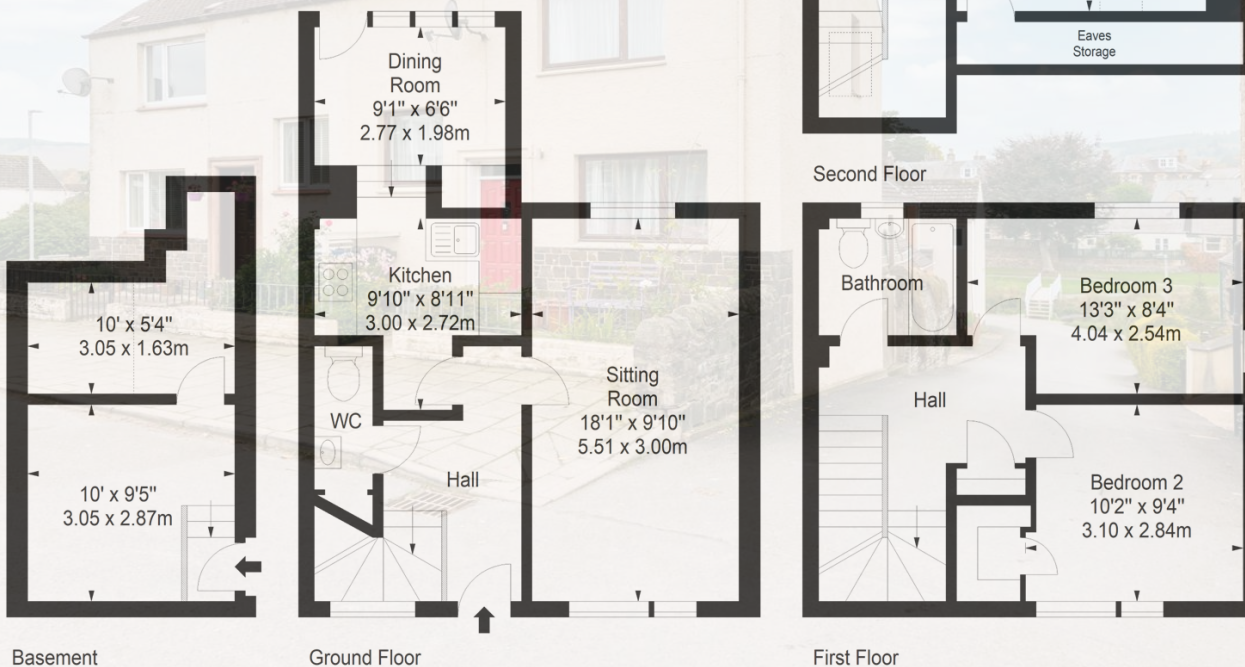
