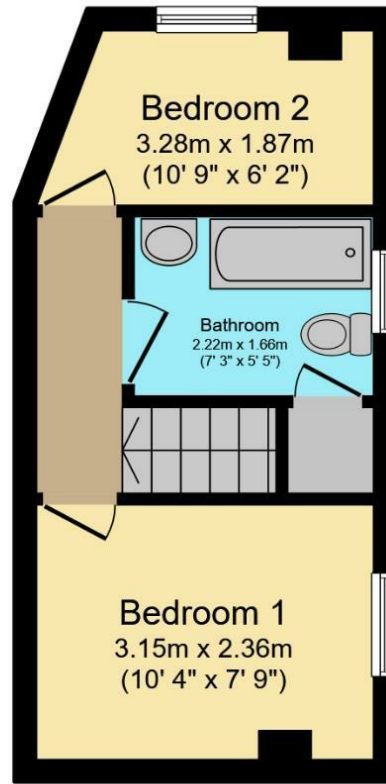






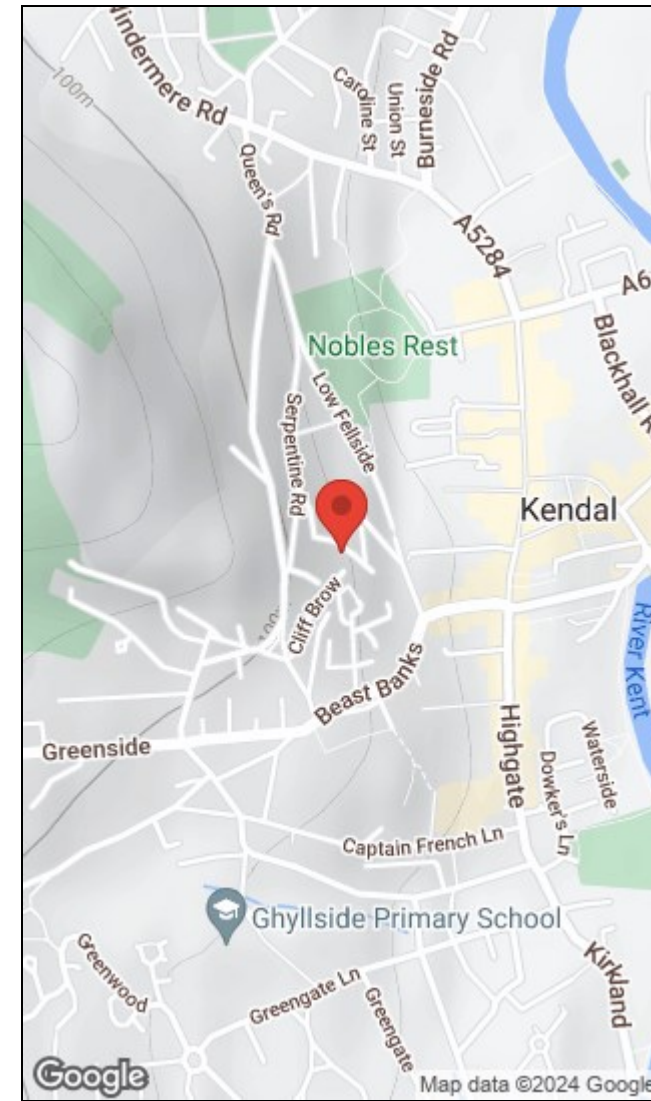


Ground Floor
