Rear aspect with fitted cupboard, laminated wooden flooring and radiator.



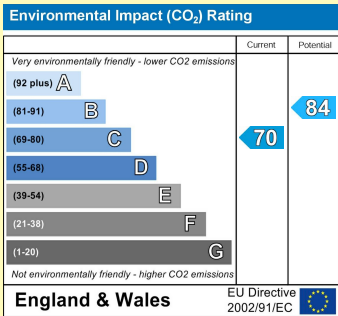
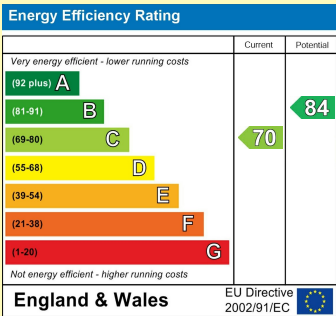
BATHROOM

Two-piece bathroom comprising of bath, vanity wash-basin with fitted cupboard below, fully tiled walls, tiled flooring and heated towel rail.



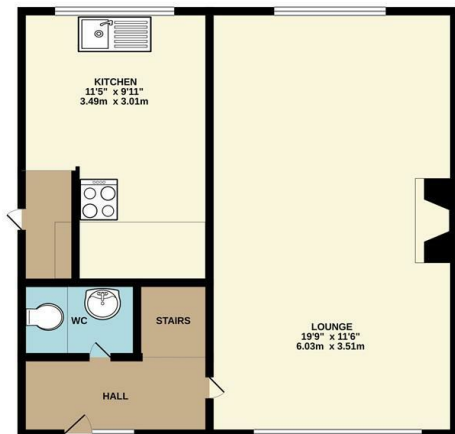
OUTSIDE

Externally to the front is a lawned garden and path to the entrance. To the rear is an enclosed lawned garden and patio and lovely golf course views.

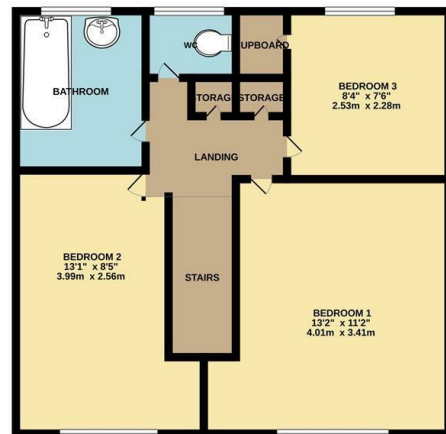
