
Three-piece bathroom comprising of bath with shower above, vanity wash-basin, low-level W.C, fully tiled walls and laminate flooring.




OUTSIDE

Externally to the front is a tarmcadam driveway affording off road parking and to the rear a large paved garden with steps up to a lawned and stone patio.





