Description

Bateman House is a four-storey office building, which fronts onto Hills Road, benefitting from excellent natural light on the floorplate. The building provides a common reception area and amenities include a secure on-site car park, covered cycle racks, WCs on each floor and shower provisions.

The available suites are split over two floors, which are the Pt. Ground and Pt. 2nd floor, both of which have been fully fitted and furnished to an exceptionally high quality. The Pt. Ground floor suite has been utilised as a client facing meeting space, which also has video call technology. The Pt. 2nd floor suite provides open plan workstations with sitstand capability on stylish parquet flooring. There is a large 10-person boardroom, 2 x 2-person meeting rooms, 2 x "Zoom Rooms" and a contemplation room, located alongside an expertly furnished kitchen and breakout facility.

Bateman house is just a 10 minute walk to Cambridge Centre. There are ample F&B facilities within a short walk located on Hills Road, Regent Street and adjacent to the Railway Station.
