Rear lobby area with access to rear garden. Access to cloakroom with toilet and hand wash basin. Single radiator


### **Master Bedroom**

We will levy the late payment until day 14 but charge from day one. The charge will be at 3% above Bank of England base rate for each day that the payment is outstanding.
