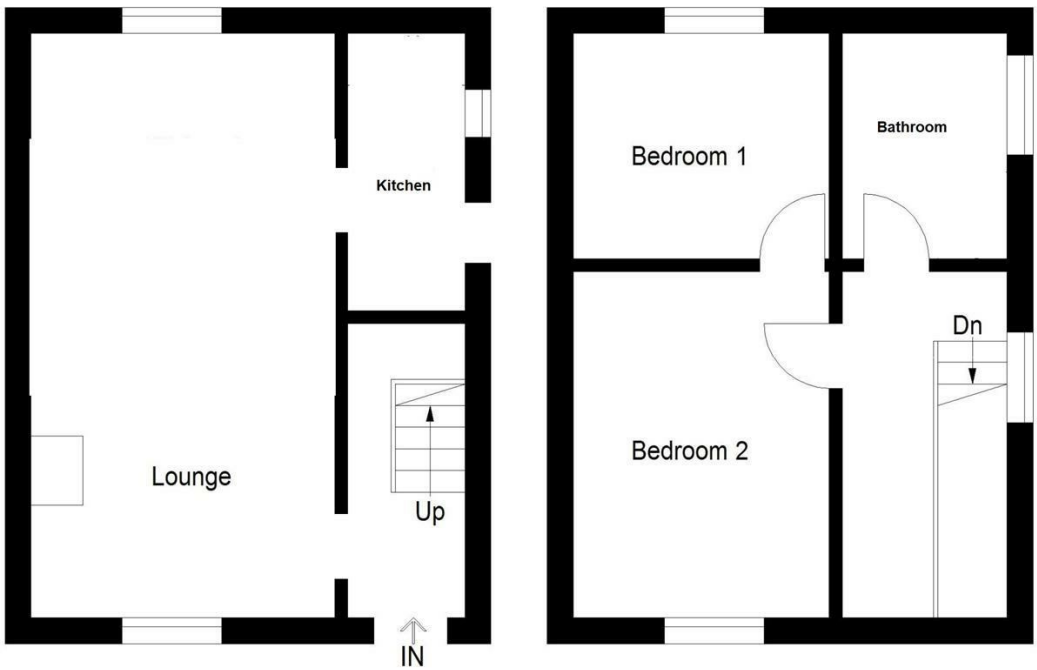

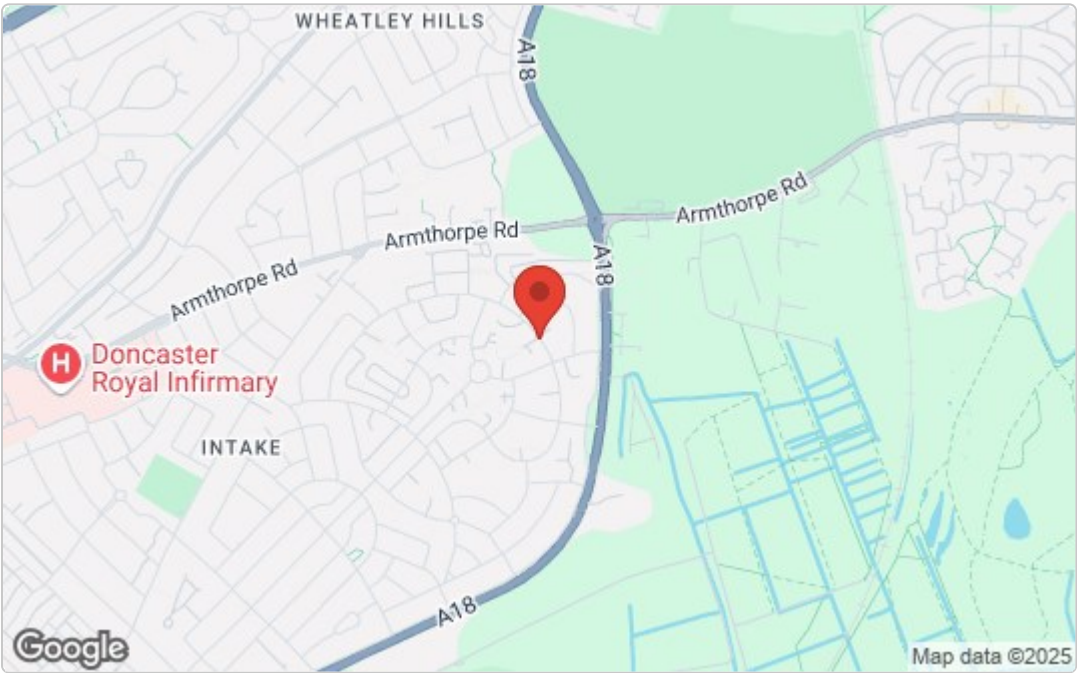


Ground Floor

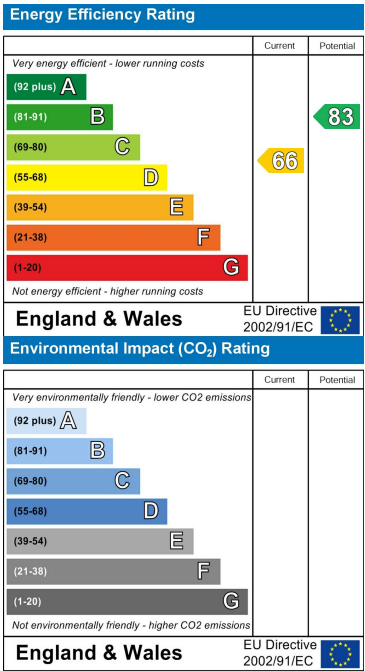
First Floor
