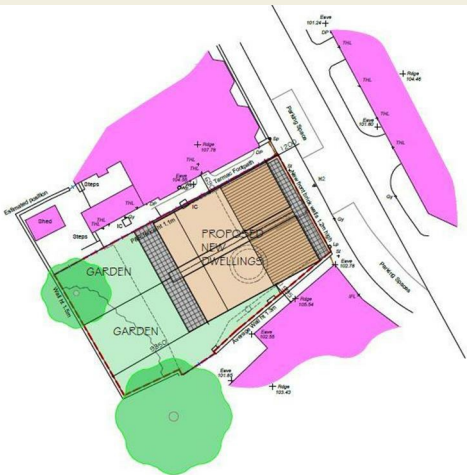

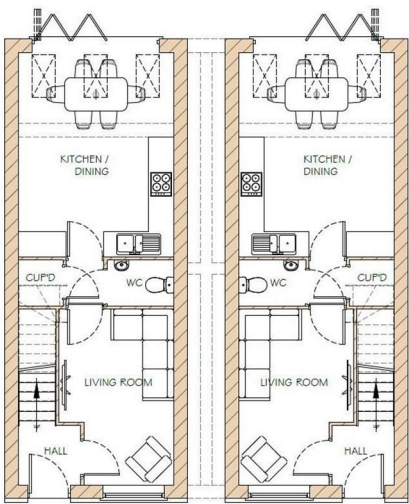
PROPOSED REAR ELEVATION

SCALE 1:200

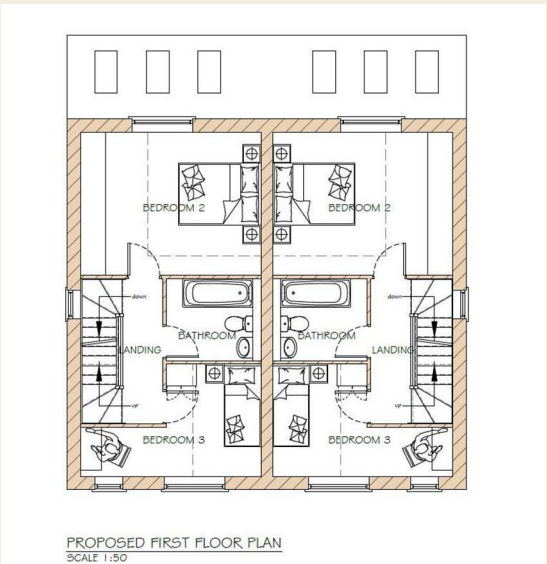
Floorplan Ground Floor



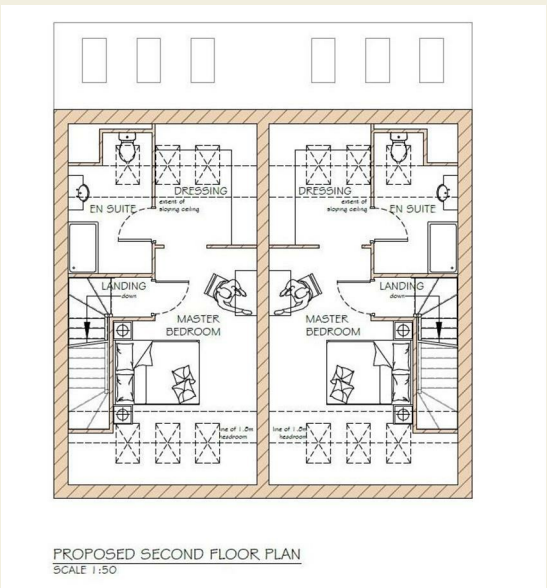
PROPOSED GROUND FLOOR PLAN

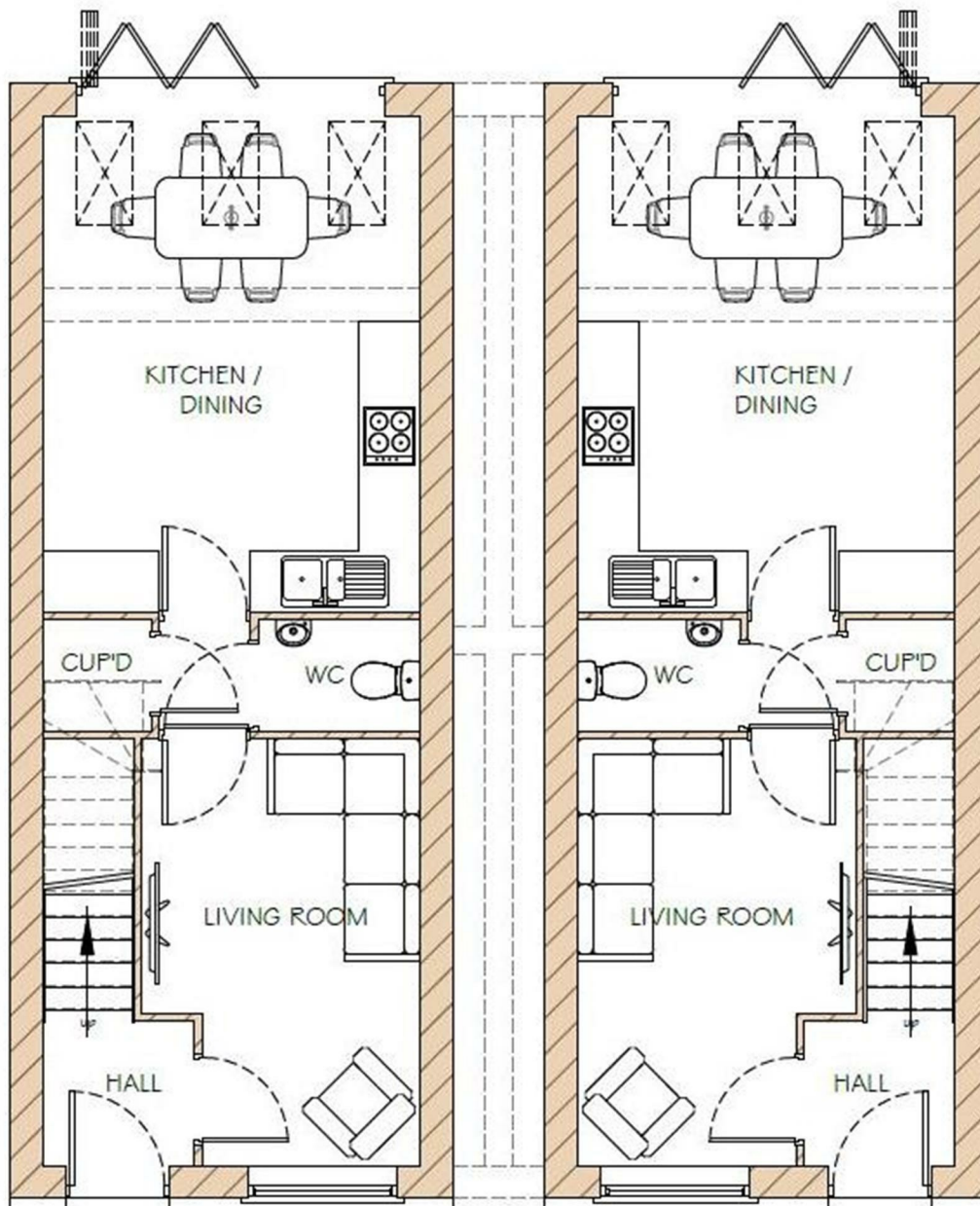

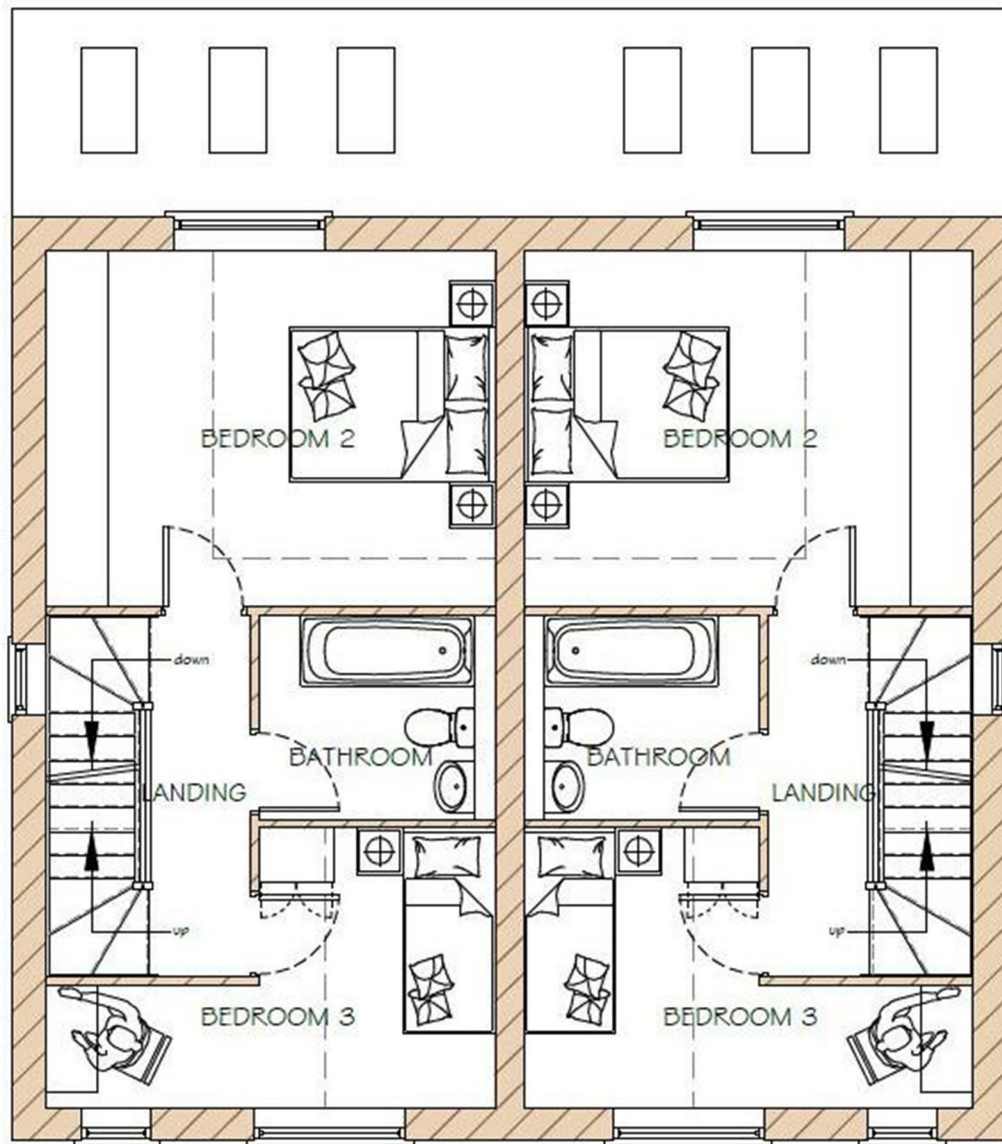

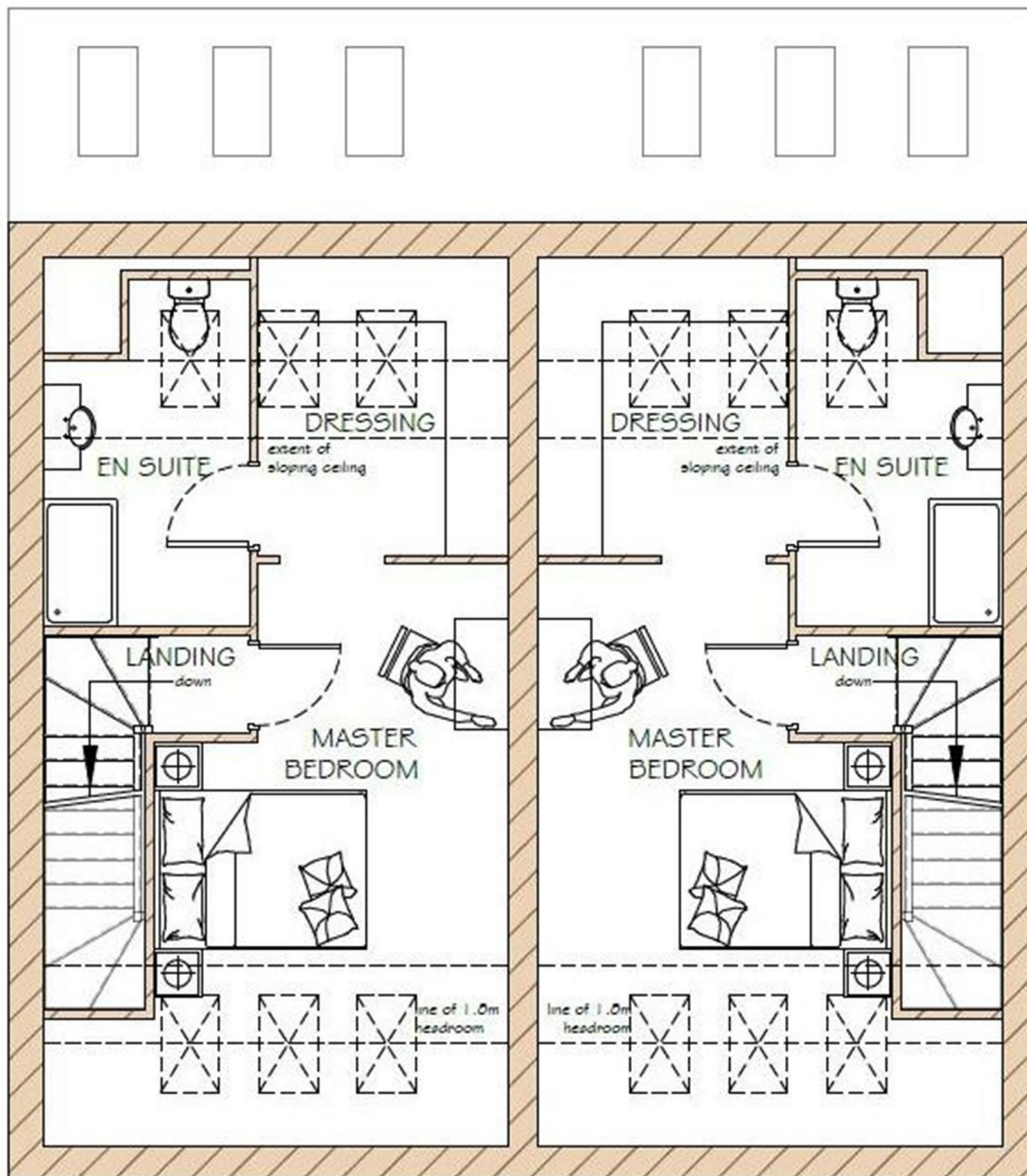


**PROPOSED GROUND FLOOR PLAN**
