## DESCRIPTION AND SITUATION

Kensington Close has always been a popular, desirable and select development enjoying a supremely convenient location within easy walking distance of the town centre and bus station. The main accommodation with approximate room sizes may be more fully described as follows:

### GROUND FLOOR:

With staircase giving access to the first floor accommodation plus central heating radiator.

#### LOUNGE 10'1" x 17'5" (3.08 x 5.32)

Wall mounted gas fire, double glazed UPVC oriel window to the front. Central heating radiator. Understairs storage area.



**DINING KITCHEN 13'5" x 9'10" (4.09 x 3.01)**

In need of refurbishment and equipped with stainless steel single drainer sink unit, plumbing for washer, double glazed window, central heating radiator, wall mounted gas condensing boiler. Door to rear garden.

**FIRST FLOOR:****LANDING**

In built airing cupboard with lagged hot water storage cylinder.

**BEDROOM 41 x 418 max (12.50m x 127.41m max)**

Fitted wardrobe, in built storage cupboard, double glazed window and central heating radiator.



**BEDROOM 7'8" x 11'10" (2.34 x 3.63)**

Double glazed window and central heating radiator.

**BATHROOM/WC 5'5" x 7'11" (1.66 x 2.42)**

Equipped with a bath with shower from mixer tap, wash hand basin, WC, double glazed window and central heating radiator.



**OUTSIDE**

The front gardens are level and comprise a lawn along with shrubs. There is gated access to the rear gardens which comprise lawns, flower beds and shrubs. There is allocated off street parking for one vehicle., access from Morven Avenue and a single garage forming part of a battery of garages also accessed from Morven Avenue. There is pedestrian access on to Church Street which, in turn, gives level access to the bus station.

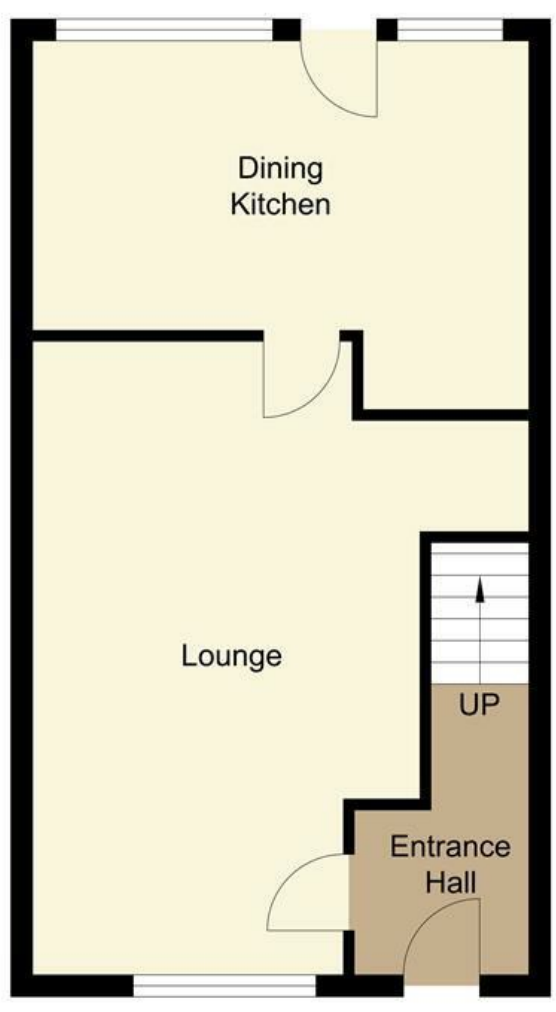
**SERVICES**

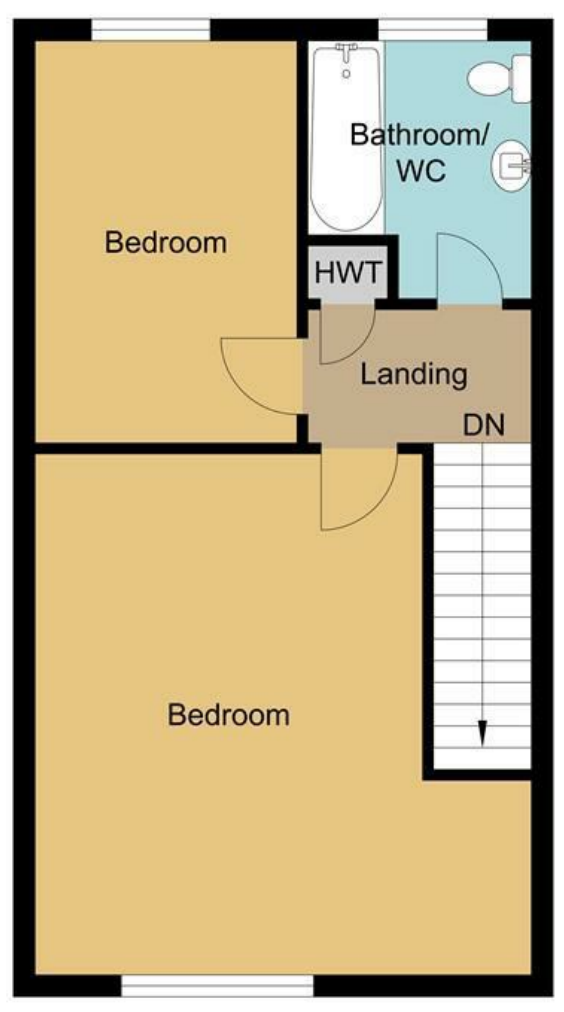
**COUNCIL TAX - BAND A**
