







Rope Street, Surrey Quays

A larger than average studio apartment, spanning 497sqft (46.2sqm), enjoying views across the marina from its second floor elevation. The property offers the original "studio-style" living with wide, bright, open spaces; the L shape affords the bedroom area privacy and also offers development potential to create a separate bedroom as at least one other in the development has done. The property forms part of Swedish Quays, a Grade II listed quayside building which dates from 1988 and is listed by English Heritage as "a successful example of townscape created by Gordon Cullen, Britain's most influential planning theorist and architectural illustrator of the post-war period." It is a design that has stood the test of time and is today known as an iconic stamp on the Surrey Quay skyline.




