Background

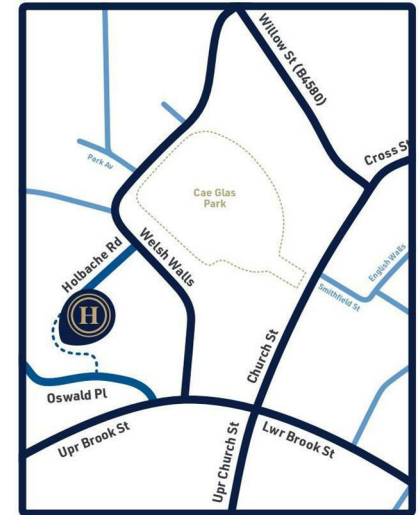
