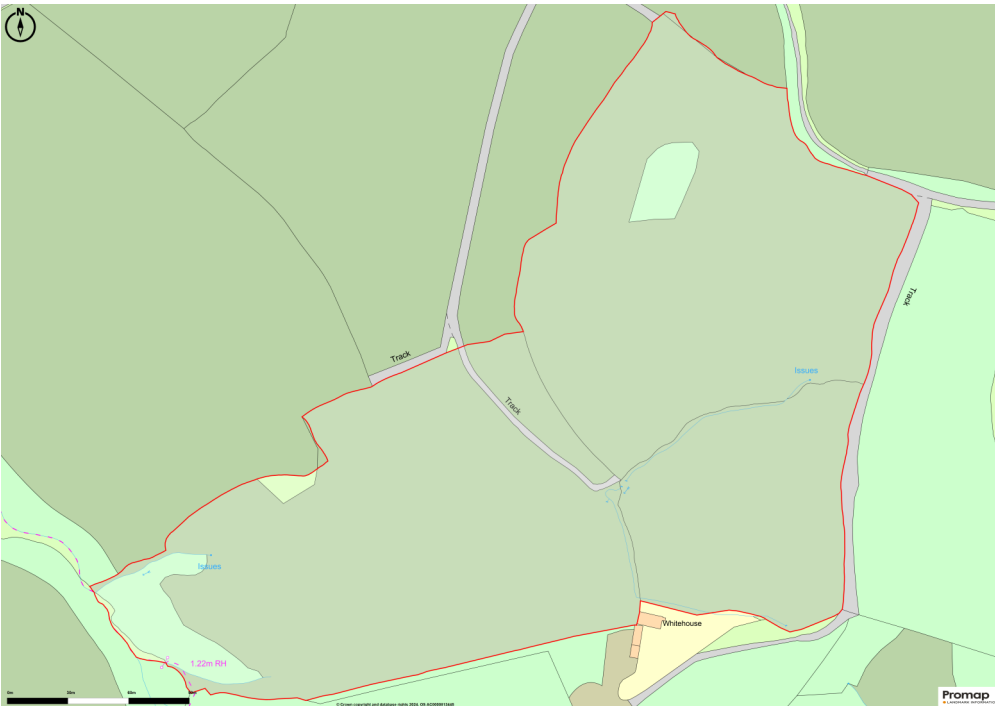

Private water supply via two Springs in the top and bottom fields. There are a number of holding tanks. Access is via a right of way across a track, just off the council adopted road.

The land would also be well suited for equestrian use and has further opportunities such as through natural capital earnings and biodiversity net gain.

Take the righthand turn onto 'the Lyde' and continue for approximately 1.5 miles and you will arrive at the hamlet of Meadowtown. Continue through Meadowtown and follow the pointer to the left hand side. Take the right hand track and in 100m, take a left. The entrance to the land will be 50m ahead, marked by a 'for sale' sign.
