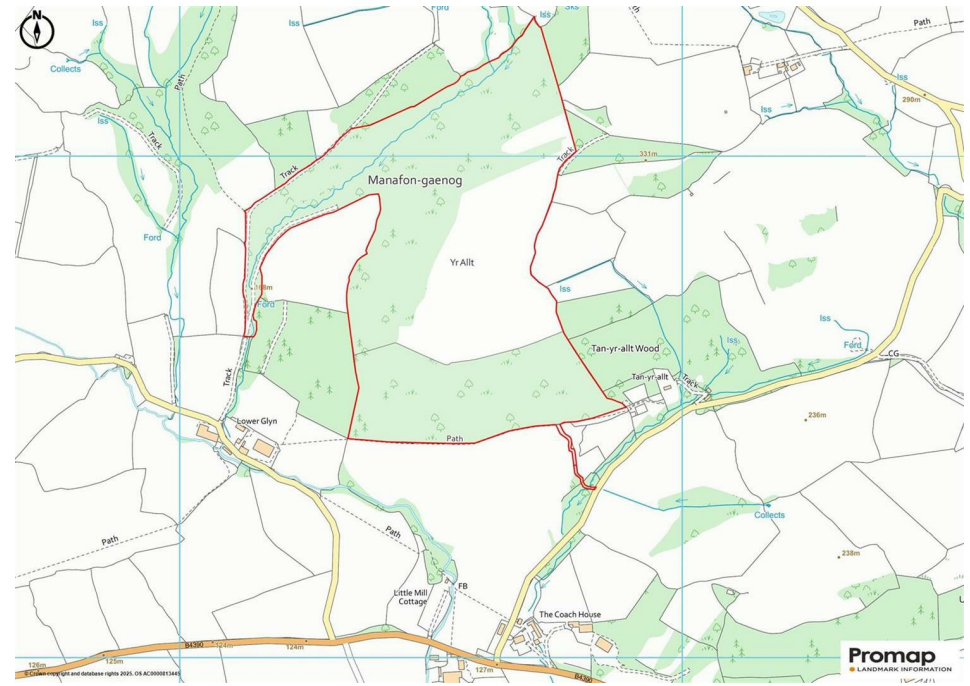






Land known as Manafon-gaenog Castle Caereinion, Welshpool, Powys, SY21 9AY Price Guide £425,000

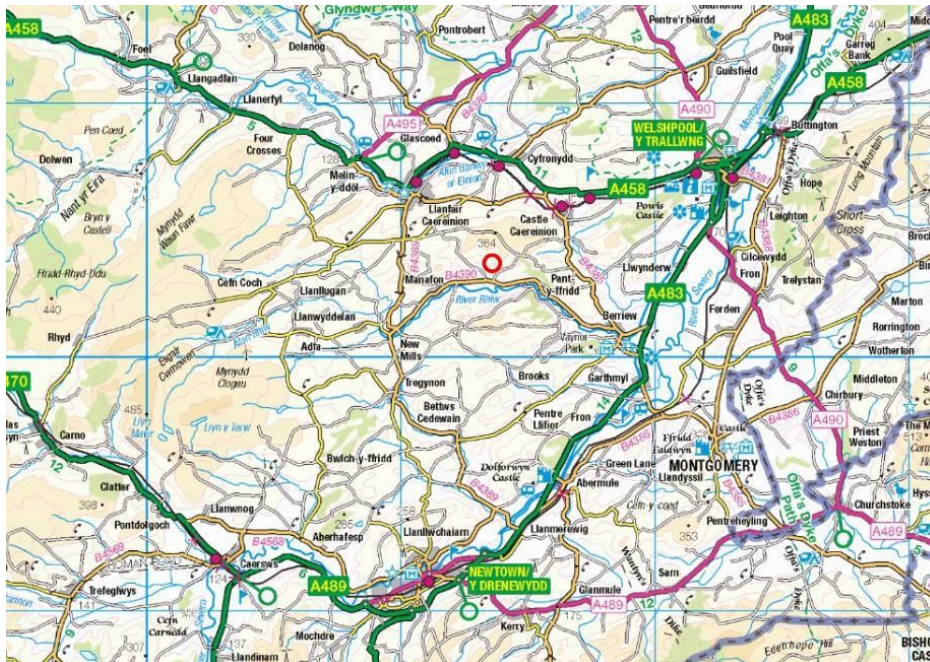
